9.2 District Update by the Superintendent

The Superintendent reported on the following:

- Superintendent Bennett asked Kirk Skorpanich to present the following RAVE Awards:
 - Felicia Asbury and Devin Gray, Teachers: These teachers have gone above and beyond, put in countless hours, and have had a huge impact on the school community by supporting the students, substitute teachers, and colleagues alike. Liberty High School began the year with two science teachers awaiting to be released from their previous districts to join the HERD. Both Ms. Asbury and Mr. Gray created lesson plans, assisted with grading, planned student class activities that were engaging, and supported the guest teachers while we waited for the classroom teachers to be released. As the new teachers transitioned into their classes, Ms. Asbury and Mr. Gray were integral to that process.
 - Christine Chavez and Josh Kitzerow, Teachers: These teachers have gone above and beyond, put in countless hours, and have had a huge impact on the school community by supporting the students, substitute teachers, and colleagues alike. Liberty was also awaiting two teachers in our CTE pathways. Ms. Christine Chavez, our Medical Pathway lead, and Mr. Josh Kitzerow, our Engineering Innovation and Design Pathway lead, also created lesson plans, communicating with parents, worked with substitute teachers, taught in classes where the vacancies existed, and have been an integral part of the HERD Pathways success.
- The ACSA Region 19 President's Reception was held on October 23rd. Kirk Skorpanich is the President this year.
- On October 30th, Trustee Campos and Superintendent Bennett attended the County Committee on School District Organization meeting.
- November 2nd-4th, Superintendent Bennett attended the ACSA State Conference in Sacramento, and Dr. Erika Tejeda received her Principal of the Year Award during the Awards Celebration Dinner.
- On November 6th, the District participated in the WRCASM bowling and membership drive. Perris Union High School District had the highest combined team score.
- The Student of the Month breakfast was held on November 8th, honoring five senior students.
- November 9th was the second Superintendent Listening Session, with students participating from all the schools in the District.
- Superintendent Bennett wished Trustee Stafford a happy birthday and presented him with a plaque thanking him for serving as President this past year.

9.4 PSEA President Jason Miller

PSEA President Jason Miller shared the following statements:

- "I would like to thank all the military, past and present, and law enforcement who keep us safe."
- "I would be remiss if I did not mention that yesterday, on your birthday, Trustee Stafford, I celebrated my 28th wedding anniversary. Thank you to my beautiful wife, two beautiful kids, and two dogs."
- "Right now, we have four professional development days per year. I am highlighting some of the things that were effective at our PD days this year and also helping you understand educators' perspectives concerning PD days in general. PSEA stands by the idea that employees need to be present on those days to foster collaboration and reflection on the teaching profession. Two of those four PD days are in August, right before school, while the other two usually are sometime in October. Teachers feel that the August PD days should be committed as much as possible to educators getting ready in the classroom for the first day and first week of school, getting their classrooms ready, setting up seating charts, and setting up their grade books, amongst many other teaching tasks for the first day and week of school. Having a successful first day and week of school will set the tone for both the teacher in the classroom and the campus itself. For the school year, that first week, that first day is incredibly important for everybody. The PD days in October are when the educators can get a different set of training and a different set of eyes on professional practice. Teachers want useful training that can be taken back to the classroom and used concretely with their classes. One particular training did a great job of having rotational presentations on student attendance; Fentanyl and An Alternative to Suspension were concrete trainings teachers appreciate and would like to take back to the classroom. Cabinet worked very hard to put together these trainings, and we're very grateful that they're open to listening to feedback for the professional development days in the future. Thank you for the time to speak."

9.5 CSEA President Nathanael Nash

- "Good evening, President Stafford and board members and Mr. Bennett. First, I'd like to say sorry for my absence during the last couple of meetings. I had to take care of some personal health days related to a work injury. But I'm here to provide you with a quick update on our ongoing efforts to foster a collaborative and positive working relationship between our dedicated members and the District over the past few weeks. We have worked with our interim labor rep, Claudia Jiménez, and engaged in constructive discussions with the District, and did a great transition while losing Lisa. CC is committed to promoting collaboration, understanding, and mutual respect. We believe that by working together, we can create an environment that supports our members and enhances the overall educational experiences of the students we support. I know we have a shared commitment to the well-being of these educators and our student's success in our community. We recognize these challenges. We recognize the challenges that are ahead of us each day. But we are optimistic that we can reach a stronger, fair, equitable, and beneficial relationship and agreements through open and transparent communications. I want to express our appreciation to the Board and the District Cabinet for their willingness to engage in conversations. Your commitment to fostering a positive working relationship is essential to the success of our members, our schools, and our students. We look forward to a productive and meaningful discussion to further a positive relationship district-wide as we go into negotiations."
- "In conclusion, CCA is dedicated to advocating for the rights and well-being of our members, and we are excited about the opportunities that lie ahead. We believe that by working collaboratively, we can create positive outcomes that will have a lasting impact on the educational community that we all serve. Thanks for your time."

9.6 Comments by the Board of Trustees

- Trustee Nelissen thanked Mr. Miller and Mr. Nash for union updates. He was glad to hear that the trainings offered at PD was beneficial for teachers. He congratulated the teachers for receiving RAVE awards. Trustee Nelissen mentioned that he was able to attend a few games within the District, including Paloma Valley's volleyball game, Liberty's volleyball game, and Liberty's last football game of the season for the league championship. He wished everyone a nice week off with family and friends.
- Trustee Campos congratulated the RAVE award recipients. He stated he was able to attend Pinacate's ELAC meeting, where students displayed Day of the Dead altar presentations in the library. He was impressed with the administration and how they handled the meeting. The parents were very proud of their kids receiving the different awards they received. He also thanked Mr. Miller for his honesty and feedback. He stated that he was glad to hear about the PD days and how the District is making things relevant, which is very important. He also requested that new teachers receive tech training on those first two PD days in August. Lastly, Trustee Campos thanked Mr. Nash for his report, thanked the staff for what they do, and hopes everyone celebrates Thanksgiving with a thankful heart.
- Trustee Garcia thanked all of the veterans and law enforcement. He congratulated Mr. Miller on 28 years of marriage and wished Trustee Stafford a happy belated birthday. Trustee Garcia shared that being a board member is unique, and they are able to hear about all the awesome things that staff and students are doing and thanked everyone for their hard work.

Vallejo shared that she attended the senior interviews for Perris High School at the end of last month and was excited to return to her old high school and participate because it reminded her of when she did the interview in her senior year in high school. She also thanked the staff and teachers for preparing the students for the real world. She stated that the City of Perris Tree Lighting Ceremony is on December 1st at 6 p.m., the Christmas parade is on December 9th at 10 a.m., and the Breakfast with Santa is on December 16th at 9 a.m. Lastly, Trustee Vallejo said she attended the Student of the Month event and congratulated the students. She appreciates being part of this District and wishes everyone a Happy Thanksgiving and to enjoy their time off.

• Trustee Stafford stated that he's been the President for the past year, and it's been a pleasure. He shared that after working for the New Jersey Fire Department for 20 years, he came to California and worked for PUHSD for 10 years. He has one more year to go on the Board and may run for another term. He thanked the community for having him, for working together, and Mr. Bennett for being so accommodating and always getting things done.

INVITATION TO ADDRESS THE BOARD OF TRUSTEES

10.1 INVITATION TO ADDRESS THE BOARD OF TRUSTEES: Non-Agendized Items

Adam Cyhan, Heritage High School teacher, made the following statements:

- "Good evening, Mr. President. Superintendent Bennett, School Board. Thank you for allowing me to speak. I'm a teacher at Heritage High School. I'm a union rep over there. But I'm actually here to talk to you about some of the goings on at a different site that I don't work at because I've been asked to by about a dozen of my brothers and sisters who work at a school where they have been displaced. I'm not here to discredit anyone or to try to point fingers at anyone, cast blame, or end this positive meeting with a downer. But I'm here to inform you that we still have a dozen teachers at Liberty High School who have been displaced and whose needs are not being met. And those teachers have exhausted all avenues. They've asked everybody that they can to intervene for them and to help them. And to this day, they're still being ignored. And what I'm talking about is you have about a dozen special education teachers who have been displaced; they're homeless. They don't have their own classroom and we know why. We know why the school is overcrowded. There are not enough classrooms. So somebody had to run. Somebody had to bear the brunt of that."
- "But I just want to give you some insight into what it's been like for them this year. When they arrived at school this year, they were told that all of their belongings would be moved into their new location, and they weren't. So, while most of us were in our classrooms prepping and getting ready for the school year, those teachers were running around trying to find their possessions that they were told were going to be moved to their classroom next year, and they weren't moved. So instead of enjoying their prep time, like we just talked about how teachers need that prep time, at the beginning of the year, they were running around looking for their stuff. And their second challenge would have been after they found their stuff, trying to find a place to work. They weren't given keys. They were sent to multiple rooms, and they weren't given keys. For many days, they had to run around every class period

of every day and find someone to open a door for them so they could do their job. And that's not a condition under which any teacher in this district should have to work. Teachers who were assigned to teach on both stories but not given an elevator key. And they're running around every period trying to find someone to open that elevator for them. Shouldn't be like that. Some of those things have been remedied. Many weeks, if not months, into the semester. Some of those things were remedied."

- "It is my opinion that it never should have been an issue. It should have been ready to go on day one. That's my opinion. So, the struggles that some of them still face, they don't have a place to work during their prep period or their conference period. Even though it is being said that there's room sharing going on. They're running around every day like it's a fresh start, trying to find somewhere to work. And then they get to a room and then, "Oh, well, you can't work here, we've already got this room go find somewhere else." "There's a meeting in here that you didn't know about; go find somewhere else." "Come on, student, that I have to test because I have to do an IEP, we found a little room. Oh, we got to go move; let me drag you around campus." That's what's happening over there right now. And it's not okay. They've done everything they can. The fact that you haven't heard from a Liberty rep is the reason why I'm here. Because they had to reach out to other reps at other schools because they were desperate for their voice to be heard. And sure, there's only a dozen of them. But every single one of them counts. If what has been said here is actually true, that we care about each other, we do right by each other. If that's true, why are these teachers still facing that every single day? Why has there not been a plan developed where they know what space they can go to work every single day without running around and scrambling, without wasting their work minutes at work, causing them to bring even more work home than they already do? It's unacceptable. And I'm here to plead to you to intervene, make this problem go away, and make sure that it gets fixed on their behalf. I'm of the opinion that they should come back to work Monday after vacation and have a clearly defined workplace for every period of the day where they know they can go and work uninterrupted and do their job. And if it can't get done by Monday, then I hope to God it's done by semester two, day one, because they deserve it as professionals. They deserve that respect. Now that we all know and we're all here from this moment on, if we don't do something to help those teachers, to show them that they really are valued and cared about and respected as professionals, Then everything that was set up until this moment is just a facade. And I think that you would all agree with me. I know there's a lot of good things going on at Liberty High School. I'm not here to try to tell you that there's not. I'm just here to tell you you have about a dozen teachers who are at their wit's end. They don't know what to do. And they feel like no one is listening, and all they want is a workspace."
- "They weren't given the carts that they were promised on day one. And by the time they got carts, no offense, they've been given the cheapest, most ineffective, impractical thing that they could possibly get. One teacher bought herself a cart because she needed it, and she still hasn't been reimbursed for the money she spent. And what's more insulting than that is that nobody even has the courage to just flat-out tell her no. They just keep blowing her off, not responding to her. Not formally telling her, "No, you're not going to get reimbursed. We're going to ignore you." Then, when the department chair for special Education tried to advocate for her employees. As her job description tells her, she is supposed to. She was shamed for doing it. So I just want to bring that to your attention, and I want you to hear it from someone other than maybe the people in charge over there because this is a real problem. And that's 12 of my brothers and sisters that deserve better. And so I'm hoping I'm hoping for real tangible action and results so that when they go back to work, they don't have to work

under those conditions because it's horrible. And there's not a single person in this room who would want to work under those conditions, myself included. Thank you for allowing me to address the board. Thank you for all that you do, and have a good night."
