Unfortunately, the hiring of one of these new teachers meant saying goodbye to a beloved teacher while she was out on long-term medical disability under less than agreeable conditions.

That being said, as the unit president, I will always seek fair, equitable treatment, emotionally and physically safe working conditions, and supervision that is impartial and never targeted. Equality in treatment that has no signs of emotional or physical harassment. In Keenan, we complete mandatory training to ensure each and every one of us, as employees of this district, understand the level of expectations when it comes to these matters. I, unfortunately, have had to have conversations that gave details of situations, conversions, and interactions between administrators and employees that crossed these lines and, at minimum, blurred those lines.

I would always hope that Mr. Skorpanich and his team, as well as all cabinet members, the superintendent, and of course, you as the trustees of this district and all of its employees to uphold the standards that are expected of us all.

As the days rush at us, my members are working hard at creating seating charts, learning student names, lesson planning, piloting science materials, acclimating the newest wave of CMI cadets, and getting to know our newest AP, I personally look forward to observations and evaluations that go smoothly for all involved in a timely and positive manner.
