

**PERRIS UNION HIGH SCHOOL
DISTRICT RESOLUTION NO. 13:22-23**

**RESOLUTION AUTHORIZING THE UTILIZATION OF A NASPO
VALUEPOINT COOPERATIVE MASTER AGREEMENT FOR THE
PURCHASE OF WIRELESS DATA, VOICE, AND ACCESSORIES**

WHEREAS, the District wishes to utilize the Master Agreement MA152-1 to purchase Cellular Wireless Services, Equipment and Accessories, and Turnkey Wireless and IoT Solutions for District use; and

WHEREAS, the State of Utah, lead agency for NASPO ValuePoint ("NASPO"), conducted a competitive solicitation process for the purchase of Wireless Data, Voice, and Accessories in accordance with Education code section 38110. The State of Utah awarded the contract ("NASPO Contract") to the responsive contractor, and authorized other public agencies, including the District, to participate in the NASPO Contract; and

WHEREAS, on August 12, 2019, the State of Utah, for itself and on behalf of NASPO ValuePoint awarded the NASPO Master Agreement to Cellco Partnership, d/b/a Verizon Wireless ("Contractor") in accordance with all terms and conditions listed in the solicitation, Solicitation# CJ 18012; and

WHEREAS, the NASPO contract, Master Agreement MA152-1, is in force and effect for five (5) years from August 12, 2019 through August 11, 2024; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase Wireless Data, Voice, and Accessories from Contractor under existing contracts, such as the NASPO Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases Wireless Data, Voice, and Accessories on the same terms and conditions as set forth in the underlying bid.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of Cellular Wireless Services, Equipment and Accessories, and Turnkey Wireless and IoT Solutions from the Contractor under the same terms and conditions as the NASPO Contract.
3. The Board has determined that utilization of the NASPO Contract is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the NASPO Contract

between NASPO ValuePoint and Verizon Wireless and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
