# **GENERAL PROVISIONS**

## 1. Contract

This Contract is entered into **16th day of June 2022** between **Perris Union High School District** (hereinafter referred to as "Local Education Agency" or "LEA") and **Thriving YOUniversity, LLC** (hereinafter referred to as "CONTRACTOR") for the purpose of providing Professional Learning for LEA.

## 2. Term of Contract

The term ("Term") of this CONTRACT shall commence on **July 1, 2022** and shall end on **June 30, 2023**.

#### 4. Rates

Consultation: LEA shall pay CONTRACTOR the in-person full day rate of \$6,500.00 per session. This price is inclusive of all travel expenses.
