

**PERRIS UNION HIGH SCHOOL DISTRICT
RESOLUTION NO. 22:19-20**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR ACQUISITION OF
DSA SHADE SHELTERS**

WHEREAS, the District wishes to purchase a DSA Shade Structure as an additional structure at Pinacate Middle School and other sites as needed; and

WHEREAS, the Colton Joint Unified School District ("CJUSD") conducted a competitive bidding process for the purchase of DSA Shade Structures, awarded the contract ("CJUSD Contract") to the low bidder, and authorized other California School districts, including the District, to participate in the CJUSD Contract; and

WHEREAS, on December 7, 2017, the CJUSD Board of Trustees awarded the CJUSD Contract to Dave Bang Associates, Inc. ("Vendor") as the lowest responsive and responsible bidder; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase materials, supplies and equipment from Vendor under existing contracts, such as the CJUSD Contract, without advertising for bids, if the Board determines it is in the best interests of the District, and the District purchases the DSA Shade Structures on the same terms and conditions as set forth in the underlying bid; and

WHEREAS, the Vendor acknowledged in the piggyback clause and signature page that the District's purchase would be subject to the same terms and conditions as the CJUSD Contract, which are binding and take precedence over any and all terms and conditions that may have been provided in the Vendor's proposal documents.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the acquisition of the DSA Shade Structures from the Vendor under the same terms and conditions as the CJUSD Contract.
3. The Board has determined that piggybacking on the CJUSD Contract is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, and the Director of Purchasing, Dawn Bray, are authorized in the name of and on behalf of the District to utilize the CJUSD Contract between CJUSD and Dave Bang Associates, Inc., pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
