## OPERATIONAL AGREEMENT Fiscal Years 2018/2019, 2019/2020, 2020/2021

This Operational Agreement stands as evidence that the Riverside Area Rape Crisis Center (RARCC) and the Alvord Unified School District intend to work together toward the mutual goal of providing quality violence prevention programming to students, parents, and faculty. All services provided by RARCC are free of charge.

The Riverside Area Rape Crisis Center will provide the following presentations per request of the Perris Union High School District: Child Abuse Prevention, Sexual Harassment Prevention, Teen Dating Violence Prevention, Rape Prevention Education, Mandated Reporter Training, Kid Power Self-Defense Workshop, and Women2Women Self-Defense Workshop.

We are also available to train and provide support services to staff members or volunteers who will lead the BeStrong and/or MyStrength Curriculums. These programs exist as violence primary prevention clubs that meet weekly during the school year. BeStrong (young women) and MyStrength (young men) are designed to address healthy masculinity and femininity, healthy relationships, self-confidence, and active bystander engagement.

All presentations are age-appropriate and can be tailored to the needs of each school. RARCC staff are available to meet with the school district and/or individual school staff to preview materials/handouts and adjust the presentation information as appropriate.

The two agencies agree to a reciprocal exchange of personnel for volunteer and staff training, or other projects where specific expertise would enhance program effectiveness. The agencies further agree to serve as resources for one another and share information in order to provide the best possible service to students, parents, and faculty.

The agencies will work together and a designated staff person will meet at least one time per year to discuss common issues, clarify working relationships, and identify any other specific service coordination activities that could offer increased benefit to our mutual clients.
