

Memorandum of Understanding

**Perris Union High School District (PUHSD)
and the
California School Employee Association (CSEA) and Its Perris Valley Chapter #469**

Campus Supervisor – Increase in Work Days

TERMS AND CONDITIONS: The Perris Union High School District (hereinafter, "District") and the California School Employees Association and its Perris Valley Chapter 469 (hereinafter, "Association."), collectively ("the parties") agree as follows:

1. Effective July 1, 2018 all Campus Supervisors in the District will be increased from 183 work days to 190 work days to provide additional professional development.
2. The additional professional development days shall be eight hours (8:00 AM - 4:30 PM) exclusive of a 30 minute lunch break. All Campus Supervisors shall be compensated for these professional development days pursuant to Article 10 in the Collective Bargaining Agreement.
3. This is a temporary one-year work year increase.
4. The work year of the Campus Supervisors is reflected in the attached document identified as Calendar "I-CS"
5. The work year will be evaluated and the parties will meet by no later than March 1, 2019 to discuss whether the work year calendar will be increased permanently.
6. This agreement sunsets on June 30, 2019.


It is agreed and understood that this agreement is subject to all approvals required under the CSEA Policy 610, as well as the Perris Union High School District Governing Board approvals.


