

RESOLUTION NO. 14:21-22

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE
PERRIS UNION HIGH SCHOOL DISTRICT APPROVING AND ADOPTING AN
ADJUSTED TRUSTEE AREA PLAN FOLLOWING THE RELEASE OF THE 2020
CENSUS DATA**

- A. On November 16, 2011, the Governing Board (“Board”) for the Perris Union High School District (“District”) took action to transition the District’s Board elections from an “at-large” election system to a “by-trustee area” election system and adopted a map option for the same.
- B. All of the then-proposed trustee area boundary plans prepared by Consultant were drawn with all applicable laws and regulations in mind, including the CVRA and federal election law.
- C. Following the District’s map adoption, the Riverside County Committee on School District Organization approved of the District’s election transition and selected a map option for use during the District’s subsequent Governing Board elections.
- D. Following each federal census, the Board must approve adjustments of trustee area boundaries, if necessary, to make sure the population in each trustee area is as nearly as equal as practicable, amongst other considerations. (Education Code section 5019.5(a).)
- E. In late September 2021, following a delay due to COVID-19, the 2020 Census data was approved and released by the California Department of Finance.
- F. The District retained GeoSpective Technologies (“Consultant”) to review the current trustee area boundary plan and determine whether any adjustments would be necessary following the release of the 2020 Census data.
- G. After review of the current trustee areas, and based on the most recent census data, the Consultant has determined that the Trustee Area map no longer has population balance under California Education Code 5019.5.
- H. The Consultant prepared an adjusted map option for consideration by the Board which would provide population balance between and among the Trustee Areas.
- I. The District solicited community feedback regarding the draft map option in a Public Hearing on December 15, 2021.
- J. On December 15, 2021, the Board initially approved of an adjusted map option but subsequently learned of minor errors in the data and map prepared by Consultant. As a result, a corrected version of that adjusted map option and data was made available.

K. With thoughtful consideration of all public input received on the draft trustee area plans and applicable state and federal legal criteria, the Board desires to adopt the trustee area plan and demographic information described as the "Adjusted Trustee Area Plan" (attached hereto as Exhibit "A") as the adjusted trustee area plan establishing the boundaries for the trustee areas as presented on January 19, 2022.

NOW, THEREFORE, the Governing Board of Perris Union High School District does hereby resolve, order and determine as follows:

1. The above recitals are true and correct.
2. The Board hereby adopts the trustee area plan (attached hereto as Exhibit "A") as the adjusted trustee area map.
3. The Board hereby authorizes and directs District staff to transmit this resolution, the final adjusted trustee area plan adopted, and any additional required documentation to the County Committee on School District Organization and Registrar of Voters and to take any other necessary action to effectuate the purposes of this resolution and to readopt the trustee area map plan.
4. The foregoing resolution shall take effect immediately upon its adoption and shall supersede the action taken on December 15, 2021, as described in Paragraph J.

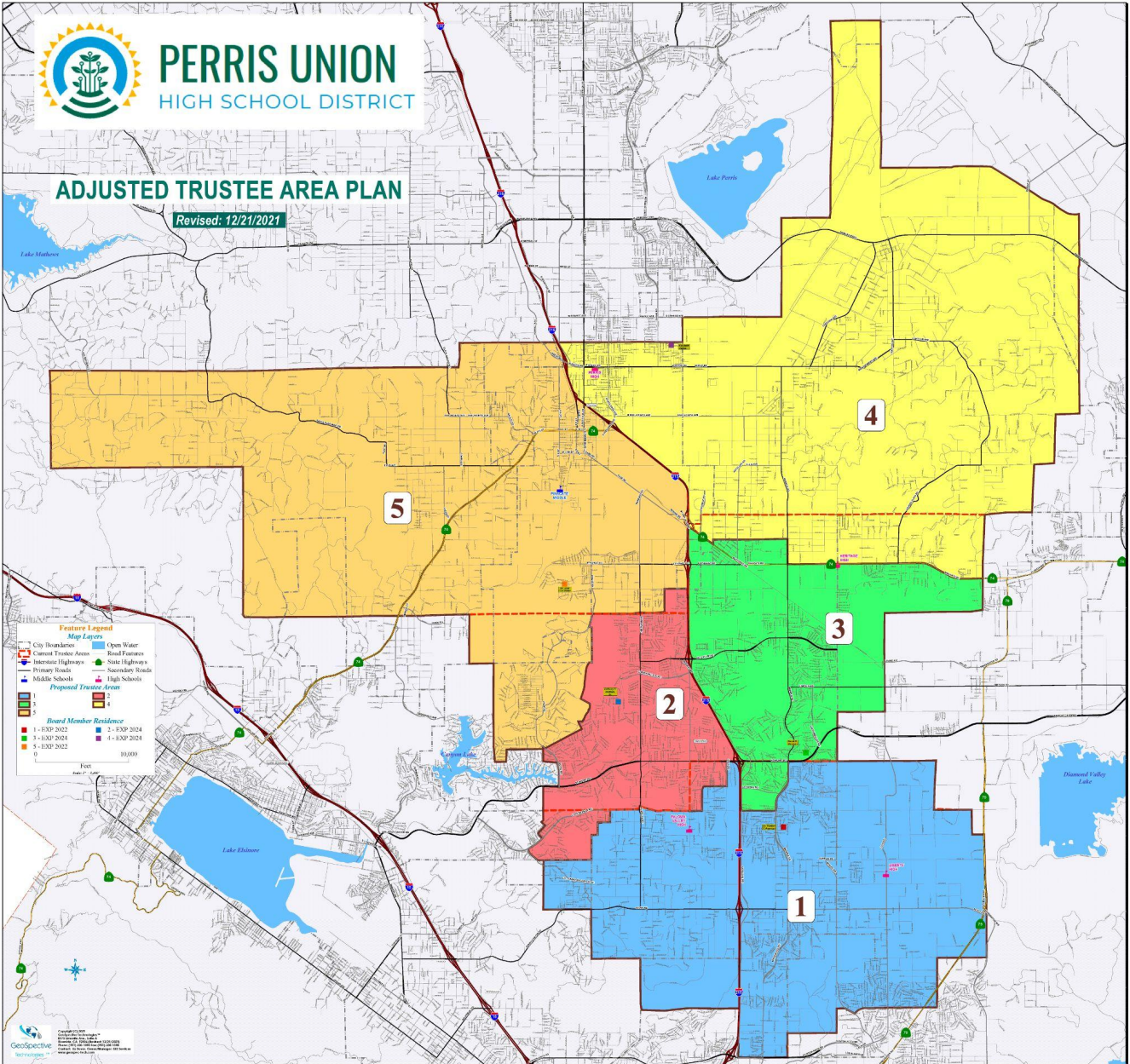
(Trustee Area Plan and Demographic Information)
