AGREEMENT WITH WALSWORTH FOR YEARBOOK PUBLICATION SERVICES AT PALOMA VALLEY HIGH SCHOOL - AMENDMENT #2

This Amendment to the Agreement for Yearbook Publication Services, made and entered into this 21st day of June, 2018, by and between the Perris Union High School District of Riverside County, California, hereinafter referred to as "DISTRICT" and Walsworth, hereinafter referred to as "CONTRACTOR".

WHEREAS the DISTRICT and CONTRACTOR entered into an Agreement to provide Yearbook Publication Services for Paloma Valley High School on June 16, 2016.

NOW, THEREFORE, the parties agree as follows:

- 1. Modify Section 1: TERM of the Agreement as follows:
 - 1.1. TERM: The term of this Agreement shall be from July 1, 2018 to June 30, 2019.
 - 1.1.1. The contract may be renewed annually upon mutual consent expressed in writing by the District and Contractor for up to two (2) additional one (1) year terms in accordance with Education Code 17596.
 - 1.1.2. The agreement will not automatically renew.
 - 1.1.3. Written notice of Contractor's intent to renew a subsequent term and its related contract shall be delivered to the Director no later than May 1 of the current contract year. For example, contracts for the third term (2019-20 school year) must be delivered by May 1, 2019.
 - 1.1.4. Attached quoted price must be in effect for the 2018-19 school year.
 - 1.1.5. All contracts shall be signed by the Director of Purchasing for the Perris Union High School District and NOT anyone at the school site.
 - 1.1.6. Escalation costs for subsequent terms must be stated in writing and approved by the District prior to the new contract term.
- 2. Modify Section 13: FEES of the Agreement as follows:
 - 2.1. FEE: For Services and Products provided under the Agreement, Students will pay Contractor based off of the rates set forth in the Walsworth 2019 Purchase Agreement

OBLIGATIONS UNDER THE AGREEMENT: The parties agree that all terms, conditions, and obligations of the agreement remain in effect throughout the Term except for those provisions of the agreement that are directly contradicted by this pricing change, in which event the terms of this extension shall control over the agreement.

SEVERABILITY: If any part or parts of this extension shall be held unenforceable for any reason, the remainder of the extension shall continue in full force and effect.
