**RESOLUTION AUTHORIZING THE PIGGYBACKING OF RFB AWARD
#540042 PEPPM 2024 MARKETPLACE BID FOR THE PURCHASE OF
SUPPLIES**

WHEREAS, on March 28, 2024, the Central Susquehanna Intermediate Unit (CSIU) requested sealed bids under Request for Bids # 540042, PEPPM 2024 Marketplace Bid; and

WHEREAS, bids were received by CSIU and evaluated in cooperation with the national PEPPM Technology Bidding Program; the bids were requested, advertised, accepted, and evaluated in accordance with the provisions of the California Public Contract Code and the Education Code; and

WHEREAS, the solicitation of bids was issued by CSIU with the intent of the resulting contracts being legally used by all public agencies throughout the United States including California school districts, county offices of education, community colleges, charter schools, other California government agencies, and agencies in other states as authorized by the California Government Code; and

WHEREAS, the vendor with the lowest prices and having a responsive and responsible bid was identified to the satisfaction of staff and agents of CSIU and PEPPM, and said bidder and supplier is Amazon.com Services LLC (Amazon); and

WHEREAS, on June 19, 2024, the CSIU awarded the Contract to Amazon ("Supplier") in accordance with all terms and conditions listed in the bid documents; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to procure various supplies from Supplier under existing contracts, such as the CSIU Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District procures supplies on the same terms and conditions as set forth in the underlying bid;

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the procurement of supplies from the Supplier under the same terms and conditions as the CSIU Contract.
3. The Board has determined that piggybacking on the CSIU Contract is in the best interest of the District.

4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the CSIU Contract between CSIU/PEPPM Technology Bidding Program and Amazon and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
