**NOW THEREFORE, BE IT RESOLVED** that foregoing its true and hereby adopted by the Board of Trustees, and the Superintendent or designee is directed to send appropriate notices to all employees whose services shall be terminated and/or hours reduced by virtue of this action. Nothing herein shall be deemed to confer any status or rights upon any employee beyond those specifically granted to them by law.
