

**AMENDMENT TO EMPLOYMENT CONTRACT OF KIRK SKORPANICH,
ASSISTANT SUPERINTENDENT OF HUMAN RESOURCES**

WHEREAS, the Board of Trustees of the Perris Union High School District and Kirk Skorpanich, Assistant Superintendent of Human Resources entered into an employment contract for the term of December 19, 2019, and ending on October 31, 2023;

WHEREAS, the Board of Trustees of the Perris Union High School District amended the Agreement on January 19, 2022 and extended the term of the agreement through January 31, 2026;

WHEREAS, the Board of Trustees of the Perris Union High School District amended the Agreement on June 18, 2022 and increased compensation consistent with a salary increase provided to all other management employees;

WHEREAS, the Board of Trustees of the Perris Union High School District and the Employee, Kirk Skorpanich, desire to amend the agreement to reflect a compensation increase consistent with that provided to all other management employees.

NOW THEREFORE, the employment contract is hereby amended as follows:

Section 4.1 is amended to state:

Salary. The annual salary of the Assistant Superintendent of Human Resources shall be as set forth in the Perris Union High School District management salary schedule, payable annually in twelve monthly installments. Effective January 1, 2023, Employee's annual salary will be \$227,447, Step 5 of a five-step salary schedule, which is attached as Exhibit A, and includes an increase of three-percent (3.0%). Similar to all other management employees, Employee's salary shall increase by an additional two-percent (2%) effective July 1, 2023. Additionally, the District will provide a stipend in the amount of \$5,000 for Charter Schools oversight each year, payable monthly, on a pro rata basis.

All other language in Article 4 shall remain unchanged and in full effect.

All other terms of the employment contract, dated December 18, 2019, and any/all other amendments, shall remain unchanged and in full effect.

IN WITNESS WHEREOF, the Board of Trustees of the Perris Union High School District and Kirk Skorpanich have duly approved and executed this amendment.
