**ELIMINATION/DISCONTINUATION AND LAYOFF OF CERTAIN CLASSIFIED  
EMPLOYEES FOR THE 2024-2025 SCHOOL YEAR**

**WHEREAS**, the Board of Trustees of the Perris Union High School District has determined that it shall be necessary to eliminate or discontinue the particular kinds of services of the District for lack of work and lack of funds pursuant to Education Code sections 45117, 45298, and 45308, as itemized in **Exhibit “A,”** at the close of the current school year; and

**WHEREAS**, it shall be necessary to terminate and/or reduce hours at the end of the 2023-2024 school year, the employment of certain Classified employees of the District as a result of this reduction or discontinuance in particular kinds of services.

**NOW THEREFORE, BE IT RESOLVED** that foregoing its true and hereby adopted by the Board of Trustees, and the Superintendent or designee is directed to send appropriate notices to all employees whose services shall be terminated and/or hours reduced by virtue of this action. Nothing herein shall be deemed to confer any status or rights upon any employee beyond those specifically granted to them by law and/or the Collective Bargaining Agreement.
