CSEA held their chapter meeting last week and welcomed Board candidates Dr. Randy Freeman and Michael Grey to the meeting. They spoke to the group as to why they would be the best candidate for the Board.

The ParaEducator conference opened up for registration and all sites were asked to submit names of those interested in attending the conference in March of 2019. President Stimach will be working with Cindy Barris, Director of Special to send about 25 employees to this valuable training event.

Last year the District spent over \$800,000 on professional development for teachers, over \$500,000 for administrators and only \$48,000 for classified. Governor Brown recently signed a Budget Trailer Bill AB 1808 which provides funding in the amount of over 50 million dollars to support professional development for classified personnel throughout the state. Though it is not known how much of this money will come to Perris Union, CSEA is excited about the possibilities.

Ms. Stimach reported that the Professional Development Days went very well and that she had received many compliments. She stated, however, the two hour session that was provided for CSEA was held at the end of the day on a Friday after two days of training and was located in the gym without an optimal sound system. This did not go over well with her members.

She was pleased to see the proclamation for parent involvement being signed this evening.

After this tragic event, he learned that the schools within the Perris Union High School District were not equipped with AED's (Automated External Defibrillators). He understood that the issue had been brought before the Board members in the past but the District chose not to pursue the matter due to costs and liability issues. He felt, however that the risks and liability were well worth the cost for saving a life. He stated that most school districts have this device except for Perris Union High School District and Perris Elementary District. He is requesting that the Board provide these devices at all the schools in the District.
