The following individual public comments were received and read by Joseph Williams, Executive Director of Technology.

Joe Connell, community member submitted the following written statement:

Good afternoon members of the PUHSD board. My name is Joe Connell and I am a parent of a junior at Heritage High. My question to you is why has it taken so long to make a decision on beginning the athletic workouts at PUHSD schools? Lake Elsinore, Murrieta and Temecula districts brought their kids back approximately 2 weeks ago. Youth leagues in the City of Menifee were given the green light to begin practices on September 1st. In fact, the Riverside County Health officials stated that youth sports could begin outdoor practices back in the first part of August. So, I ask again, why have you waited? Allowing the sports teams in this district to return for conditioning / workouts will give these kids some sense of normalcy. It will not only be extremely beneficial for their physical health (not to mention the fact that it will assist in reducing injuries once their seasons begin) but it will probably be even more beneficial in improving their mental health by allowing them to feel like a normal high school student athlete again. So please, I beg of you, do the right thing and allow these student athletes to return immediately. I thank you for your time.

Will cheer happen? Are we wasting money on uniforms that might not ever be used? Can we have the coaches hold off on spending until we get a firm answer?
