

**PERRIS UNION HIGH SCHOOL DISTRICT  
RESOLUTION AUTHORIZING PIGGYBACKING FOR THE PURCHASE  
OF JANITORIAL AND SANITATION SUPPLIES**

**WHEREAS**, the District wishes to utilize the Administrative Services Agreement to purchase janitorial and sanitation supplies for use at District school sites; and

**WHEREAS**, the Etiwanda School District (“Etiwanda”), a California school district, issued Bid No. ESD-2019-20-002 and Etiwanda Board of Trustees subsequently awarded the bid to Hillyard, Incorporated (“Supplier”) on September 12, 2019 (“Master Agreement”), as may be amended from time to time in accordance with the terms thereof, for the purchase of Supplier’s catalog; and

**WHEREAS**, the Foundation for California Community Colleges (“Foundation”), a 501(c)(3) nonprofit organization, worked with Supplier to make this Master Agreement available to any and all public agencies, public and private school district, as well as public and private colleges or universities through the cooperative purchasing program known as CollegeBuys; and

**WHEREAS**, it has been determined that it is in the best interest of the District to utilize the Piggybackable Contract for the purchase of janitorial and sanitation supplies; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase various products under existing contracts, such as the CollegeBuys Agreement, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases janitorial and sanitation supplies under the same terms and conditions as set forth in the underlying bid;

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of janitorial and sanitation supplies under the same terms and conditions as the CollegeBuys Agreement.
3. The Board has determined that piggybacking on the CollegeBuys Agreement is in the best interest of the District.

4. The Deputy Superintendent of Business Services, Candace Reines or Admin Designee, is authorized in the name of and on behalf of the District to utilize the CollegeBuys Agreement between Etiwanda School District and Hillyard, Inc. pursuant to the piggybacking procedures of Public Contract Code section 20118 and to execute any documents and take all necessary actions to effect the intent of this Resolution.
