**AGREEMENT TERM – 3 YEARS**

- 3-year agreement – start date 3/16/2023
- Year 1 – 3/16/2023 thru 12/31/2023
- Year 2 – 1/1/2024 thru 12/31/2024
- Year 3 – 1/1/2025 thru 12/31/2025
- PALOMA HS has first right to request an extension of the term at any time during the 3 year partnership

**AGREEMENT COMPS/REBATES/DISCOUNTS -**

**COMP PRODUCT –**

- GAME ONE WILL PROVIDE COMP PRODUCT ON UNIFORM PURCHASES IF AVAILABLE FROM UNIFORM MANUFACTURER CHOSEN BY COACH/SPORT
- GAME ONE WILL PROVIDE ANNUAL BONUS OF \$2,500.00 COMP PRODUCT AT THE BEGINNING OF EACH YEAR OF CONTRACT

**REBATES -**

- GAME ONE WILL PROVIDE A YEARLY COMP PRODUCT REBATE BASED UPON PALOMA HS TOTAL YEARLY SPEND OF NON-COMPED PURCHASES.
- \$5,000 - \$24,999 REBATE AMOUNT TO BE 2%
- \$25,000 - \$49,999 REBATE AMOUNT TO BE 3%
- \$50,000 + REBATE AMOUNT TO BE 5%
- ALL ONLINE STORES (TEAM AND CAMPUS WIDE) WILL COUNT TOWARD YEARLY SPEND TOTALS
- ALL SPENDS OF AFFILIATED CLUBS/ JR PROGRAMS / COMMUNITY PROGRAMS AND COMMUNITY PARTNERS REFERRED BY PALOMA WILL COUNT TOWARD THE TOTAL SPEND
- ALL COMP PRODUCT ALLOCATIONS WILL BE CALCULATED AT MANUFACTURER'S FULL RETAIL LIST PRICE
