7.1 Report Out of Closed Session

There was no report out of Closed Session.

7.2 District Update by the Superintendent

The Superintendent reported on the following:

- Superintendent Grant Bennett stated the start of school went well. He thanked M&O and the administration for going out to the sites and assisting with directing traffic before and after school.
- Construction update:
 - Perris High School has construction in the front of the campus, near the football field, and an Ag Mechanics building being built in the back of the school.
 - Paloma Valley High School construction of the pool is underway. The public library previously housed on campus has relocated and the space will be reconfigured into the main office.
 - Heritage High School does not have any construction taking place at the moment. However, construction for the new pool will start at a later date.
 - Perris Lake High School is remodeling a number of classrooms to accommodate CTE classes, including video production and culinary. The Adult Education office is also being remodeled.
 - o Pinacate Middle School has no current construction projects.
 - California Military Institute has a new gym. The portables have been relocated to the back of the campus and the area will be the new staff parking lot. The student restrooms have also been updated.
 - Liberty High School construction should be completed by January 2022.
- The California Military Institute Gymnasium and Parking / Circulation Project Dedication will be held on Wednesday, September 29th at 2 pm.
- There is currently a shortage of guest teachers, custodial subs, campus supervisor subs, para-educator subs, and NSA subs. The District is working diligently to hire qualified substitutes.

- Summer School Graduation took place on July 23, 2021, at Heritage High School.
- The new teacher orientation was July 30, 2021. Approximately 30 new teachers were in attendance. After the orientation, they were taken on a bus tour of the District and school sites.
- Social workers have started working with students. There is staff at each school site and a district-wide social worker located at the Student Service Center.
- Students seem happy to be back at school, which is exciting to see.
- Superintendent Bennett shared the District Mission Statement which reads "The mission of the Perris
 Union High School District is to create high-quality relevant learning opportunities for all in a safe and
 caring environment. We will develop a high quality, caring staff who will be dedicated to learning, and
 connect students to their education and potential goals. We will care for all students while developing a
 growth mindset through collaboration, creativity, communication, and critical thinking".
- Mr. Bennett shared that with regard to COVID related issues, the District takes direction from the CDPH, CDC, RCPH, OSHA for physical distancing, masking, barriers, and other protocols. He emphasized the school board and administration do not set these guidelines; however, they do follow their guidance.
- Lastly, the District has held seven vaccination clinics with plans for more for staff, students, and the public. Information will be going out regarding dates, times, and locations.

7.5 Comments by the Board of Trustees

Trustee Vallejo stated she was excited to hear summer school was a success. She shared her appreciation of NSA's, custodians, staff administrators, and teachers for their dedication and hard work.

Trustee Nelissen welcomed everyone back. He stated he is very proud of how the District dealt with COVID the last year and a half realizing it has been difficult at times. He was excited to see the District was able to open a new high school even during the pandemic. He would like to take a tour of all the campuses within the next couple of months. Trustee Nelissen then thanked all the teachers, staff, and administrators for everything they've done, and are currently doing, to help get students educated and provide them a safe place for education. He also thanked Nutrition Services for making sure all students are fed.

Trustee Freeman stated he is very proud of how staff and students have handled the pandemic and that building a new high school during this time is amazing. He also attended the summer school graduation and enjoyed seeing the students walk across the stage wearing their respective school cap and gown.

Trustee Stafford welcomed everyone back for the new school year. He thanked everyone for their hard work and dedication and stated he is happy students were able to return to campus this school year.

Trustee Araux welcomed everyone back to the 2021-22 school year. He thanked the cabinet, administrators, teachers, and classified staff for the wonderful service they provided to students this past year and a half. He also thanked the parents for their support, commitment, and understanding. He is happy to see all the improvements that are taking place at the school sites, and is happy Paloma is getting the pool that was promised to them back in 2014. Trustee Araux also stated the District is going to have the opportunity to make a difference in students' lives this school year. There is an identified need to provide social-emotional support, and he is excited to see the District has social workers ready to work with students and provide the support they need. He thanked the Board for supporting the academic focus on addressing and identifying the challenges regarding the learning gap.

She stated that CMI does not have any hand sanitizer stations in the classrooms or in the lunch area. Also, several teachers are not wearing their masks in the classrooms. When asked by students why they are not wearing them, they indicate that they don't have to because they are vaccinated. According to the CDC, a vaccinated individual can still transmit the virus even if they do not show any symptoms. Ms. Lopez is asking that hand sanitizers are made available to students in both the classroom and the lunch area. Also, teachers wear their masks in the classroom. In addition Ms. Lopez asked for updated COVID information on the District's website. Finally, Ms. Lopez shared that her daughter appreciates being back in school and thanked the Board for their time.

CMI parent, Matilde Quintana, also shared her concerns about the lack of hand sanitizers on campus and to make masks mandatory for all individuals on campus. In addition, Ms. Quintana requested that filtered water be made available to all the students at CMI.
