1. **Full-Time Equivalents:** The Superintendent's Career Technical Education Program, upon request of the DISTRICT, agrees to employ <u>6</u> Career Technical Education Instructors, at an annual cost of <u>\$91,528.75</u>, including salary and benefits per teacher. The Agreement may be amended to cover any increases in salary or benefits for the fiscal year, which are approved and implemented by the SUPERINTENDENT.

To assist the DISTRICT with CTE programming, the SUPERINTENDENT will "phase-in" costs of instructor(s) position(s) over three (3) school-years. Listed below is the percentage for year 2.

All other terms and conditions of the contract shall remain the same.
