## PERRIS UNION HIGH SCHOOL DISTRICT RESOLUTION AUTHORIZING PIGGYBACKING FOR THE PURCHASE OF CHEMICALS: ACIDS, INORGANIC FOR POOL MAINTENANCE

**WHEREAS**, the District wishes to utilize the Master Agreement MA-080-22010504 to purchase Chemicals; Acids, Inorganic for use for District school site pools; and

**WHEREAS**, the County of Orange Public Works ("OC Public Works"), issued Bid IFB-080-C033959-DC-2 and subsequently awarded the bid to Waterline Technologies, Inc. ("Supplier") on September 30, 2021 ("Agreement"), as may be amended from time to time in accordance with the terms thereof, for the purchase of Supplier's catalog; and

**WHEREAS**, the OC Public Works Master Agreement MA-080-22010504 ("Agreement") is in force and effect from September 30, 2021 through September 29, 2026; and

**WHEREAS**, the OC Public Works worked with Supplier to make this Agreement available to any and all public agencies, public and private school district, as well as public and private colleges or universities; and

**WHEREAS**, it has been determined that it is in the best interest of the District to utilize the Piggybackable Contract for the purchase of Chemicals; Acids, Inorganic; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase various products under existing contracts, such as this Agreement, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases Chemicals; Acids, Inorganic under the same terms and conditions as set forth in the underlying Agreement;

## NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

- 1. The foregoing recitals are true and correct.
- 2. The Board hereby approves the purchase of Chemicals; Acids, Inorganic under the same terms and conditions as this Agreement.
- 3. The Board has determined that piggybacking on this Agreement is in the best interest of the District.

4. The Deputy Superintendent of Business Services, Candace Reines or Admin Designee, is authorized in the name of and on behalf of the District to utilize this Agreement between OC Public Works and Waterline Technologies, Inc. pursuant to the piggybacking procedures of Public Contract Code section 20118 and to execute any documents and take all necessary actions to effect the intent of this Resolution.
