4.3 Principal's Update

Dr. I. Nicholas Milosavljevic updated the Board on the following:

- CMI recently had a great WASC visit and received some additional documentation regarding the visit, which will be shared in more detail in the near future.
- The teachers had a very successful AVID training. CMI is making good progress in reaching the goal of becoming an AVID demonstration school.
- Another goal that is in progress is for CMI to become a Professional Learning Community (PLC) demonstration school. Several teachers took part in training with the Solution Tree company. Dr. Milosavljevic thanked the board and cabinet for their support in helping to attain that goal.
- In terms of community service, the holidays are a fun and celebration time. In contrast, it is also difficult for many of our community families. Initially, the school held a food drive, hoping to reach a goal of 1,000 cans of food. As of this morning, the amount of food collected is over 4,000 cans, which is amazing and will help many families in the community.
- CMI cadets currently participate in the Honor Memorial in Arlington Cemetery. The school was recently informed that the cadets were selected to service Gold Star family events. Gold Star family events are unique in that they are designed to help serve families who have lost a loved one in combat. It's quite an honor for our cadets to represent, and serve, the community in this new capacity.
- Dr. Milosavljevic noted that one item Cadet Commander Garcia didn't share earlier was that he is preparing to go to India. Commander Garcia received a scholarship to represent the Cadet Corp. He was selected from several candidates in Riverside County and will join other cadet leaders from around the world in India over Christmas break.
- Lastly, a slight correction from Commander Garcia's report earlier stated 300 cadets were recently promoted. There were actually 600 students who were promoted, and we are very proud of them.
