**RESOLUTION AUTHORIZING THE PIGGYBACKING OF RFB AWARD
#535802 PEPPM 2023 APPLE BID - PENNSYLVANIA FOR THE
PURCHASE OF TECHNOLOGY PRODUCTS MANUFACTURED BY
APPLE INC. AND APPLE-BRANDED SERVICES**

WHEREAS, on October 21, 2022, the Office of the Central Susquehanna Intermediate Unit (CSIU) requested sealed bids, under Request for Bids # 535802, PEPPM 2023 Apple Bid - Pennsylvania (CSIU Contract) for the purchase of technology products manufactured by Apple Inc. and Apple-branded services; and

WHEREAS, bids were received by CSIU and evaluated in cooperation with the national PEPPM Cooperative Purchasing Program; the bids were requested, advertised, accepted, and evaluated in accordance with the provisions of the California Public Contract Code and the Education Code; and

WHEREAS, the solicitation of bids was issued by CSIU with the intent of the resulting contracts being legally used by all public agencies throughout the United States including California school districts, county offices of education, community colleges, charter schools, other California government agencies, and agencies in other states as authorized by the California Government Code; and

WHEREAS, the vendor with the lowest prices and having a responsive and responsible bid was identified to the satisfaction of staff and agents of CSIU, and said bidder and supplier is Apple Inc. (Apple); and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase various technology products manufactured by Apple and Apple-branded services from Supplier under existing contracts, such as the CSIU Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases technology products on the same terms and conditions as set forth in the underlying bid;

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of technology products manufactured by Apple and Apple-branded services from the Supplier under the same terms and conditions as the CSIU Contract.
3. The Board has determined that piggybacking on the CSIU Contract is in the best interest of the District.

4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the CSIU Contract between CSIU/PEPPM Cooperative Purchasing Program and Apple Inc. and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
