#### **Overview**

This document serves as the Statement of Work (SOW) to define the scope of a PowerSchool Professional Services project. This SOW includes add-on services that will be provided to Customer in support of their use of the Unified Insights platform.

Perris Union High School District has elected to implement the Unified Insights Local Control & Accountability Plan Module. This module consists of two, distinct parts:
