7.3 CMITA President Angel Love-Behrens

CMITA President addressed the Board on the following:

Good evening School Board Members, Superintendent, and Cabinet. I apologize, as I'm not feeling great today. But I felt that what needed to be addressed at this evening's board meeting was important enough for me to be here and set my physical feeling of not being well aside for the moment. Let me get right to the heart of the challenges that CMITA has faced in recent months and the fight that has just begun.

We were delayed by months starting the negotiation and discussions regarding the cost of living budget as it is triggered in May of 2023 when the State of California posted it at 8.22. Due to oversights and miscommunications with HR, our time with equal attention and focus was not given in a timely manner. Not only were we delayed in the matter of the cost of living raises, but we were also delayed in having our Sunshine articles for the renewal of our contract delayed. We presented our Sunshine for contract renewal on December 1, 2023, only to find out that it did not make the agenda for the December meeting. When Mr. Skorpanich was questioned on why this happened, it was explained to us that it was not a definitive deadline. During this discussion, I was given the impression that agendizing board items is more of a moving target type of thing, that the persons responsible for addressing and/or responding to the Sunshine were short on time of being able to address it and have it on the agenda. Suggested timelines instead of deadlines to present items for placement on the public board agenda have never been the business standard when it came to the unions in this district. Deadlines were adhered to, or it didn't happen. I've personally been told that before, when I've missed these deadlines things that I needed, or my unit needed, to be addressed by this board. I didn't meet the deadline; better luck next month. At least, this was what CMI has always been told. I'm disappointed in CMITA being set aside yet again when it comes to processes of union communication and businesses. That being said, I look forward to you approving the Sunshine this evening so that once the issues of the COLA raises have been addressed, we can move forward. Let my closing statement be the firmest and the loudest; CMITA being a small unit, still stands with the bigger units of this district; and with the classified unit even though they don't have a union contract yet. The State of California has posted, upheld, and fully funded a cost of living increase of 8.22. We, as the teachers of the district, are in the front line of delivering the high-quality education with the standards and expectations that our administration, this cabinet, and this board expect us to fulfill. The quality education to the students that we deliver, we deserve the increase in full as budgeted by the State of California.

Dr. I. Nicholas Milosavljevic, Principal, provided the Board and Cabinet with the following update:

- Enrollment is staying strong and steady, especially for this time of year.

- The attendance rate is currently at 95 percent. Dr. Milosavljevic gave credit to the CMI attendance team and all the staff who are working very hard to make sure students are taken care of. One of the ways they do that is they pay close attention to the monthly attendance reports. Staff looks and follows the trends very closely so there is a quick response to any changes. November and December are usually difficult months for schools. But, CMI is exceeding their data even from last year.
- One of the measures of success rate at CMI is how the students are doing on the passing rate. When students were not doing well back in 2020 due to COVID, CMI was able to reduce those rates and is looking at a 71 percent improvement as of right now. This is a testament to the staff and the work they are doing.
- Lastly, Dr. Milosavljevic congratulated Assistant Superintendent Robert Brough on his retirement and expressed his gratitude for his support of CMI.
