<u>Perris Union High School and Jane Scibilia</u>, together henceforth referred to as "Clients", hereby agree to the following terms concerning the Formal/Prom taking place on <u>Saturday</u>, <u>May 22, 2021</u>.

Payments

Clients' use of the event center's facilities and related services space will be confirmed by this signed contract and paid Space Reservation Fee equivalent to 25% of the total estimated charges at the time of booking. This will secure for Clients the date, time, and space chosen, as well as the minimum subtotal required by Wedgewood Weddings Menifee Lakes. All payments made will be credited to the final balance of the event.

An additional payment that will bring the client's balance to at least 50% paid will be due 180 days in advance of the event date. These payments may be made in the form of credit card, personal check, cashier's check, or money order. Cash payments will not be accepted at any time. Payments made by check must be payable to Wedgewood Weddings.

All charges are an approximation, and may change with any client requested adjustments to the services and guest count until 10 days prior to the event date — at which point the minimum guaranteed attendance and

final payment are due. Neither personal checks nor cash will be accepted for final payments . After final payment is received, contracted services will be procured; therefore, the minimum guaranteed attendance may not be reduced.

Should the guest count increase within the final 10 days before the event, that number will become the new guaranteed count. Any guest count increase made after the 10 — day-out final payment must be confirmed in writing and accompanied by full payment of any additional costs. If the day — of attendance exceeds the guaranteed guest count, Clients will be charged 1.5 times the per person price for each additional guest. No refunds will be provided in the event that actual attendance falls below the final guaranteed count.

If the event is canceled within 60 days of the event, the full remaining balance of all estimated charges will be due to Wedgewood Weddings.
