BE IT RESOLVED that the Board of Trustees of the Perris Union High School District hereby determines that the following positions be abolished for lack of work and/or lack of funds pursuant to Education Code sections 45117 and 45308.

BE IT FURTHER RESOLVED by the Board of Trustees as follows:

1. That due to a lack of funds and/or lack of work, the number of classified management employees and the amount of service rendered shall be reduced by layoff as specified above, pursuant to Education Code section 45117.
2. That said layoff shall become effective on July 1, 2018 for employee # 256406 and #255382, October 19, 2017 for the vacant position.
3. That the Superintendent or his designee is directed to give notice of layoff to the affected classified management employees pursuant to the requirements of law.
4. That any employees laid off pursuant to this Resolution shall be eligible for reemployment pursuant to Education Code sections 45298 and 45308.
