DISTRICT RESOLUTION NO. 14:22-23**

**RESOLUTION AUTHORIZING THE UTILIZATION OF CALIFORNIA
MULTIPLE AWARD SCHEDULE #4-20-78-0089C FOR THE PURCHASE
OF ARTIFICIAL TURF**

WHEREAS, the District wishes to utilize the California Multiple Award Schedule (CMAS) #4-20-78-0089C to purchase artificial turf for District use; and

WHEREAS, KYA Services, LLC is the Base Schedule Holder of California Multiple Award Schedule (CMAS) #4-20-78-0089C, based on products and/or services and prices from the California Department of General Services (DGS) Schedule #47QSMA20D08P7; and

WHEREAS, any services acquired using this CMAS will be incidental to the purchase of material/supplies; and

WHEREAS, the CMAS is in force and effect for five (5) years from February 11, 2020 through February 10, 2025; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase artificial turf from Contractor under existing contracts, such as this CMAS, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases artificial turf on the same terms and conditions as set forth in the underlying CMAS.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of artificial turf from the Contractor under this CMAS.
3. The Board has determined that utilization of this CMAS is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize this CMAS as awarded to KYA Services, LLC and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
