

**PERRIS UNION HIGH SCHOOL
DISTRICT RESOLUTION NO. 15:22-23**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR PURCHASE OF
PERFORMING ARTS APPAREL, INSTRUMENTS, FURNISHINGS,
STORAGE, AND RELATED SERVICES**

WHEREAS, the District wishes to utilize the Master Intergovernmental Cooperative Purchasing Agreement to purchase various Performing Arts Apparel, Instruments, Furnishings, Storage, and Related Services for use at District sites; and

WHEREAS, the Region 4 Education Service Center ("Region 4 ESC"), lead agency for OMNIA Partners Cooperative Purchasing Program, ("OMNIA") conducted a competitive solicitation process for the purchase of Performing Arts Apparel, Instruments, Furnishings, Storage, and Related Services in accordance with Education code section 38110. Region 4 ESC awarded the contract ("OMNIA Contract") to responsive suppliers, and authorized other public agencies, including the District, to participate in the OMNIA Contract; and

WHEREAS, on November 1, 2019, the Region 4 ESC Board of Trustees awarded the OMNIA Master Contract to Music & Arts, Stanbury Uniforms, Inc., and Wenger Corporation ("Suppliers") in accordance with all terms and conditions listed in the request for proposals; and

WHEREAS, on May 2, 2022, the Region 4 ESC Board of Trustees extended the contract to these suppliers through October 31, 2023, which maintains these contracts in effect and valid; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase various Performing Arts Apparel, Instruments, Furnishings, Storage, and Related Services from Suppliers under existing contracts, such as the OMNIA Contract, without advertising for bids, if the Board determines it is in the best interests of the District, and the District purchases Furniture, Installation and Related Services on the same terms and conditions as set forth in the underlying bid.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of Performing Arts Apparel, Instruments, Furnishings, Storage, and Related Services from the Suppliers under the same terms and conditions as the OMNIA Contracts.
3. The Board has determined that piggybacking on the OMNIA Contracts is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the OMNIA Contracts between OMNIA and Music & Arts, Stanbury Uniforms, Inc., and Wenger Music Center pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
