

**PERRIS UNION HIGH SCHOOL DISTRICT  
RESOLUTION NO. 38:22-23**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR THE PURCHASE OF  
SCHOOL BUSES**

**WHEREAS**, the District wishes to purchase School Buses for student transportation services in an estimated amount of \$1,374,649.56 (“Contract Price”); and

**WHEREAS**, the Hemet Unified School District (“Hemet USD”), conducted a competitive solicitation process for the purchase of School Buses in accordance with Public Contract Code section 20111. Hemet USD awarded the contract (“Hemet USD Contract”) to BusWest, and authorized other California School districts, including the District, to participate in the Hemet USD Contract; and

**WHEREAS**, on May 21, 2019, the Hemet USD Board of Trustees awarded the Hemet USD Contract to BusWest (“Supplier”) in accordance with all terms and conditions listed in the request for proposals; and

**WHEREAS**, on May 18, 2022, the Hemet USD Board of Trustees extended the above referenced bid through June 30, 2023, and is therefore still valid and enforceable; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase School Buses from Supplier under existing contracts, such as the Hemet USD Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases School Buses on the same terms and conditions as set forth in the underlying contract;

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of School Buses from the Supplier under the same terms and conditions as the Hemet USD Contract.
3. The Board has determined that piggybacking on the Hemet USD Contract for the purchase of School Buses is in the best interests of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the Hemet USD Contract between Hemet USD and BusWest and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
