HIGH SCHOOL GRADUATION REQUIREMENTS

The Governing Board desires to prepare all students to obtain a high school diploma so that they can take advantage of opportunities for postsecondary education and employment.

Course Requirements

To obtain a high school diploma, students shall complete at least the following courses in grades 9-12, with each course being one year unless otherwise specified:

1. Four courses in English (Education Code <u>51225.3</u>)

2. Three courses in mathematics (Education Code <u>51225.3</u>)

At least one mathematics course, or a combination of the two mathematics courses, shall meet or exceed state academic content standards for Algebra I or Mathematics I. Completion of such coursework prior to grade 9 shall satisfy the Algebra I or Mathematics I requirement, but shall not exempt a student from the requirement to complete three mathematics courses in grades 9-12. (Education Code <u>51224.5</u>)

3. Three courses in science, including biological and physical sciences (Education Code <u>51225.3</u>) (cf. <u>6142.93</u> - Science Instruction)

4. Three courses in social studies, including United States history and geography; world history, culture, and geography; a one-semester course in American government and civics; and a one-semester course in economics (Education Code 51225.3)

5. One course in visual or performing arts

(cf. <u>6142.6</u> - Visual and Performing Arts Education)

6. Two courses in physical education, including health education, unless the student has been otherwise exempted pursuant to other sections of the Education Code (Education Code 51225.3)

7. One Course of a World/Foreign Language.

8. Completion of Free Application for Federal Student Aid (FAFSA) or California Dream Act application is required for graduation from the comprehensive and alternative high schools.

9. Limitations:

Office/student aide:

10 credits maximum (Office aides are Seniors ONLY: Office Aides receive Pass/Fail grade only, which are not to be used to determine athletic eligibility. In order to be considered for an Office Aide position, students must be on track for graduation.)

Work Experience: **Community Service:** ROP/CTE:

The remaining credits required for graduation will come from available elective courses.

Because the prescribed course of study may not accommodate the needs of some students, the Board shall provide alternative means for the completion of prescribed courses in accordance with law.

Exemptions and Waivers

A foster youth, homeless student, former juvenile court school student, or child of a military family who transfers into the district any time after completing his/her second year of high school shall be required to complete all graduation requirements specified in Education Code 51225.3 but shall be exempt from any additional district-adopted graduation requirements, unless the Superintendent or designee makes a finding that the student is reasonably able to complete the requirements in time to graduate by the end of his/her fourth year of high school. Within 30 days of the transfer, any such student shall be notified of the availability of the exemption and whether he/she qualifies for it. (Education Code 51225.1)

Retroactive Diplomas

Any student who completed grade 12 in the 2003-04 through 2014-15 school year and met all applicable graduation requirements other than the passage of the high school exit examination shall be granted a high school diploma. (Education Code 51413)

The district may retroactively grant a high school diploma to a former student who was interned by order of the federal government during World War II or who is an honorably discharged veteran of World War II, the Korean War, or the Vietnam War, provided that he/she was enrolled in a district school immediately preceding the internment or military service and he/she did not receive a diploma because his/her education was interrupted due to the internment or military service. A deceased former student who satisfies these conditions may be granted a retroactive diploma to be received by his/her next of kin. (Education Code 51430)

In addition, the district may grant a diploma to a veteran who entered the military service of the United States while he/she was a district student in grade 12 and who had completed the first half of the work required for grade 12. (Education Code <u>51440</u>)
