



## EVENT CONTRACTING AGREEMENT

Agreement made this **27th** day of **November, 2023**, by and between **LED ENTERTAINMENT** and **California Military Institute**, (referred to as the "Customer") for the purpose of contracting event services between the undersigned parties.

  - Games – Foosball, Air Hockey, Pool table, Retro game stations
- Grand Entrance
  - Stanchions with black velvet ropes
  - Red carpet
- Security (mandatory pat downs and purse checks)
  - guards (at least 1 female)
- Catering- appetizers , desserts and beverage station.
- Staff for all set up and tear down/clean-up of items provided by LED and/or LED's vendors
- Certificate of General Liability from LED and any applicable vendors

1. Payments. All payments are final. No payment or any portion made under this Agreement is transferable or refundable.

2. LED Entertainment shall not be required to refund any part of Customer's paid total cost in the event of inclement weather (e.g. rain, wind) or due to causes that are beyond its reasonable control, including but not limited to acts of God, war, strikes or labor disputes or government orders. Customer agrees to bear the risk of any such inclement weather events. If additional costs are accumulated while providing goods and services to protect against inclement weather, the cost will be the responsibility of Customer. LED Entertainment shall not

be responsible for any delays to the event due to weather.

3. Customer agrees to hold LED Entertainment harmless from any and all liability, loss or damages the Customer may suffer as a result of cancellation or Interference with Customer's scheduled event, other than by the misconduct of LED Entertainment.

4. Damage. Customer shall pay the replacement value of all property and equipment, lost or stolen, and will bear the cost of repairing all damages to the facility, its grounds, and equipment caused by Customer or Customer's guests.

5. Any misconduct or possession of unauthorized alcohol or illegal substance at the time of the event will not be tolerated and shall constitute cause for immediate termination of the event. If the event is terminated for this reason, Customer shall be responsible for full payment and costs of event.

6. Customers guest under 18 years of age must be chaperoned by parents, faculty or staff members. LED Entertainment. will not provide chaperones.

7. LED Entertainment shall not be responsible for any damages or loss whatsoever to any vehicle of Customer or Customer's guests or agents while arriving, attending or departing event. Furthermore, LED shall not be responsible for any personal injuries sustained by Customer or Customer's guests or agents while in parking areas, designated or not.

8. Venue Cancellation. In the event that the contracted venue, regardless of reason, becomes unavailable for the event date described in this agreement LED Entertainment will make every effort possible to book a venue of similar size, quality and location. The loss of a contracted venue does not void this agreement. All specific terms and conditions remain in force.

9. Customer hereby agrees that no guest of Customer shall bring on the event premises any articles of the following: inflammable materials, explosives, firearms, illegal substances, articles of a dangerous/damaging nature or alcoholic beverages. Customer agrees the indemnify and hold LED harmless from any and all liability, loss or damage to either Customer or LED may suffer as a result of damages caused by breach of this provision. LED Entertainment reserves the right to have confiscated all such articles brought into an event.

10. All vendors and event services must be contracted through LED Entertainment.

11. This agreement shall be governed by the laws in the State of California without regard to its conflicts of law rules.
