10.2 District Update by the Superintendent

The Superintendent reported on the following:

• Superintendent Bennett stated that tomorrow is the last day of the first semester. He shared it wasn't easy, however, the students persevered and are making strides, and getting lined up where they need to be

- The District has a vaccine clinic for staff and students on Friday, December 17th, at Heritage High School.
- Superintendent Bennett thanked Dian Martin for organizing the adopt a student family program, which was a huge success. It's great to help those in need, and she does a great job.
- Liberty High School's Women of Will Program had a canned food drive for Thanksgiving and collected close to one thousand cans to give to a local pantry in Menifee. They are also finishing up a toy drive and will give the toys to a local community organization.
- This morning, Cabinet went to the school sites to recognize the District-Wide Employee of the Year recipients.
- Lastly, Superintendent Bennett stated that he had the opportunity to be Santa at numerous events within the City of Perris. He also visited Paloma Valley High School's severely handicapped class where the students were excited to meet Santa.

10.3 Student Representatives to the Board of Trustees

The student representatives from the school sites presented their video reports to the Board of Trustees on the events and activities for each respective school site: Heritage High School student representative(s) - Mikayla Jacobs and Kaiden Olmos; Liberty High School student representative(s) - Moeana Mou and Samantha Sena; Paloma Valley High School student representative(s) - Meagan Macatangay and Cassandra Madrigal; Perris High School student representative(s) - Nicole De La Torre Hernandez and Daisy Sanchez; and Pinacate Middle School student representative(s) - Balinda Hain and Audrina Leon.

10.4 PSEA President Jason Miller

PSEA President Jason Miller shared the following statements:

- "Merry Christmas and Happy New Year from PSEA.."
- Our Special Education teachers are some of the hardest working people in the District. Their job is one of the more physically demanding jobs on our campuses. The number of students special education teachers have had to serve has increased substantially since the pandemic. They have to focus so much on classroom management. Many of them teach classes while also maintaining a separate caseload. PSEA has great respect for the work that special education teachers do. Some of the successes they have had include: mild severe has had a new functional classroom for moderate-severe students with cash registers, work items, and social areas to learn working and social skills. Perris UHSD has had twenty-one, special education seniors, complete the Department of Rehabilitation Packets for employment services after high school graduation to meet most of their transition plan goals. IEP meetings are being held on time and occurring smoothly. Learning centers are open periods one to seven with a special education teacher to support students with reading, organization, tests, and quizzes. Lastly, new paraeducators have been hired to help deliver services throughout the District."
- "There were some very concerning events last Tuesday, December 7th, at Heritage High School. It was presented to me that seven fights, two lockdowns, and a gun threat of some kind on a single day

revolved around football players who have had many behavioral problems since the beginning of school. Serious behavioral problems that have been swept under the rug by the athletic director and others cite administration at Heritage. We are not so much upset that this happened; although that is a thing, we are more upset that very little was done from site administration to prevent this and preventable it was. Our site reps and PSEA members had been telling site-level administration about these safety issues for a while, and our members felt like they were met with excuses from the site administration. Members felt like their concerns, many of which were quite serious, were dismissed and not dealt with by site administration. There is a sense among our members at Heritage that the football players rule Heritage High School, and those in charge somehow protect them at Heritage. We have heard the students are afraid of the football players. Some PSEA members lost their lunch on that day, and we feel they should be compensated; members and students lost their lunch while students in trouble got fed from site administration during the lockdown. Teachers gave their lunch that they had brought from home to their students during the lockdown. I asked reps that morning to talk to site administration to see if they could perhaps change the schedule for later in the day so that the first lunch could happen—crickets from site-level administration. Site-level administration seemed more intent on keeping students in class during their lunch during class time. It would seem site-level administration understands that the teachers can handle discipline. But that is what a site-level administration job is. Why is the union or Heritage even having to tell site-level administration what they should do for campus safety outside of the classroom? It would seem that safety would be one of the core job functions of site-level administration. Teachers know what's up. These fights weren't happening in the classroom because, for the most part, if a teacher has bad classroom management, it is a stressed city for the entire year. Where was the Cabinet in all this? The Cabinet was most excellent in this process. They had already been working with the site admin for plans to increase the safety of the campus before December 7th. But it feels like the site admin either didn't listen to their bosses or maybe didn't have the skillset to know how to implement what the Cabinet told them. I'm not sure where the breakdown was, but I know it was not with the Cabinet because they had told me before this date they were working on plans and policies to help site administration with safety at Heritage. I want you to know I hate saying these hard things. I really hate it. I would rather talk about Christmas, Santa Claus, or Grant-A-Claus. I would rather be talking about student and teacher success, not fights or violence, or missed lunches, or bad student behavior left unchecked. Teachers and students at Heritage need help, and PSEA and the Cabinet have vowed to bring that help. I am not the union person that wants to bring up hard stuff to fight with the administration, and there are union people like that. Nor am I the union person that wants to shame anyone. But these things I have to talk about, I've talked about these things tonight because they were too big for my members, for me to ignore and talk about. Thank you for this time."

10.5 CSEA President Josh Rushing

CSEA President Josh Rushing shared the following statement:

"Safety has always been my thing. Every time, whether it's COVID, whether it's staff safety, everything.
 There seems to be a lot of growing pains this year, and you know, we all kind of knew it. We were gone

for a year and a half, both the staff and students. You have to grow back into doing things, and unfortunately, most of our kids are taking longer to learn that curve. I'm hopeful something can be done to address safety. Perris High has had some issues, and Heritage had some issues, but I trust that everyone here is responsible enough to know that safety is paramount for our students and staff. Happy holidays! You guys have a couple of agreements tonight that you're voting on, so it'll be an awesome Christmas present that we ratify and get a bonus. Have a good night and see you next month."

Trustee Araux thanked teachers, classified staff, and CMI staff for the excellent job and the support they gave students this semester. In addition, he wished everyone Happy Holidays.

Trustee Stafford stated he is concerned about the safety of students and staff and wants the best for them. He also wished everyone a Merry Christmas and a safe holiday.

Trustee Freeman stated that he attended the vaccination clinic at Heritage High School in November and received his booster. He also attended the California School Boards Association conference in San Diego and came away with a lot of excellent information.

Trustee Vallejo stated she is glad, and excited, to serve as clerk for this year's Board. She congratulated students and staff for almost completing the end of the first semester. She wants everyone to know that the Board is doing everything they can to ensure the safety of the students and staff. Trustee Vallejo wished everyone a Happy Holidays.

Trustee Nelissen wished everyone Happy Holidays. He stated that safety is a big concern for the Board and took notice of the events that happened. He thanked Mr. Walters for sending him an invitation to The Murder Mystery play. He stated that he took his family, and it was very entertaining.
