She asked staff to look into the ratio of students per campus supervisors at each site; i.e. putting more of them at a larger site and less of them at a smaller site. She also indicated that it would be helpful for the campus supervisors to know about dangerous students and/or students with special needs, so that when they came in contact with those students they would be better equipped to handle the problem.

PSEA President, Vickey Mueller stated that communication was much better in the solving of grievances. She stated that the Special Education teacher-to-student ratio has improved. Address to PUHSD Board of Trustees, February 15, 2017

Paul Clay

Hello, and thank you again for this opportunity to address the Board of Trustees.

I don't know where to begin, so I'll just dive in. There are still problems here in this district; as with most other employees I've spoken with, I believed that once there was a new chief administrator, things would improve. They have. But there are still so many things wrong that I feel compelled to address these three issues.

I have written three complaints since last August without resolution; it even appears that there have been no investigations related to these complaints. Allow me to remind you that when complaints were written against me, or against another union activist, district administrators exhibited a certain *zeal* in pursuing investigations, even when they thoroughly lacked any evidence.

One complaint involved the district's continued failure to comply with State Law, specifically, Education Code 49079, which carries with it misdemeanor penalties including fines and jail time. Administration has failed to resolve this complaint.

The second complaint involved the outrageous conduct of an administrator who began a witch hunt against an activist member of PSEA without a complaint, without any witnesses, without any evidence, but merely upon a rumor alone. The complaint was not limited to that one act, but rather resulted in a five-page complaint for a myriad of violations, to which there has been no response.

Finally, in the third complaint I cited an administrator at Heritage who exhibited reproachable conduct in an issue to which, again, there has been no response.

I ask that you compel this administration to take this seriously.

Good evening Members of the board I am Angelica Apodaca PSEA executive board member I would like to introduce some of our executive board members. I am requesting that this become part of the permanent record. We are here to voice our concerns of the process for evaluating new teachers. The reason why we have these concerns is because we have a teacher shortage and about the mixed messages new teachers are receiving. These are some of our concerns.

- Teachers are being evaluated by administrators that have not been in a classroom.
- Teachers are being evaluated by someone with no knowledge of the content area.
- Contrary to the contract new Teachers are given 7 periods which causes unfair burden for a teacher trying to learn the workings of a school
- New Teachers are populated with the students with discipline issues that could not be managed in a tenured teacher's classroom.
- It appears evaluation procedures are not being followed in example
 1. Pre-observation meeting are missed
 2. Lesson plan for evaluations are not discussed prior to observation
 3. Observations are missed without notifying teacher
 4. Lastly teachers are given stellar evaluations until their last evaluation which is right before the decision to non re-elect.

- One of the biggest problems we see is at the Academy, our educational options program
- For three years we have shared our concerns with the district
- Last year we were encouraged to hear that our concerns were being handled with the implementation of changes intended to address recurring issues
- However, because of these changes, expectations placed on Academy teachers are far more than those placed on a teacher at any other site
- We have learned that these changes are asking teachers to teach multiple new, different programs concurrently with no contractually required planning, and no formal training
- The Academy Community Day School is to provide instruction to at risk students in the following four settings:
 - The Community Day School for Students who have formally been expelled from a comprehensive high school or a middle school as well as students struggling with behaviors in the Ed Options Setting
 - The Educational Options Program and the Academy Middle School for students who have been recommended for expulsion, but are currently on a contract in lieu of expulsion

- Lastly a districtwide Independent Study Program for students who are not having success in the traditional setting and are exploring independent studies as an option
- Due to the new programs and limitations of the number of teachers on site, each teacher has a class comprised of a mixture of 8-11th grade students and must find a common standard for the entire class
- Many students, including those who could not be successful in a traditional school environment, are now being placed in front of a computer from 745 until they are dismissed at 2
- For students working on the online system, teachers have been asked to create individual instruction plans even though these are INDEPENDENT STUDY computer classes, meant to be self contained, with students working independently at their own pace, on their own subject
- With only one teacher per subject currently there is at least one teacher creating lesson plans for 11 different subjects to accommodate the online programs
- Realistically if more students are enrolled, this teacher could be required to lesson plan for an additional 17 online classes
- In comparison, a traditional high school teacher has a max load of three courses
- For the ISP program, teachers are given a checklist that must be followed for each student during a scheduled weekly meeting

- Some teachers are required to meet with up to 5 students per hour, making it impossible to meet these requirements and does not allow for meaningful, personalized interaction between the teacher and student
- These expectations of their teaching responsibilities were not clearly stated when positions were being offered at this site
- As an educational options site, we are not meeting the needs of the students in relation to what they deserve
- We don't know everything but we know enough to say that NO ONE...NO ONE could be successful with all the changes taking place at the Academy
- As we consider the teachers who were not renewed at this site, our president, Vickey Mueller will read from a blog that was written just over a year ago by the school's administrator about one of this year's non reelects
- It is subtitled "Superstar Teacher at the Academy" and it can be found on the PUHSD website
