## 9.5 PSEA President Jason Miller

PSEA President Jason Miller shared the following statements:

- "Congratulations to the people of the year. Congratulations, Bob, to some of the PSEA members, John Muhammad, Rachel Post, one that used to be a PSEA member, and officer Bevy Escobar, an amazing employee."
- "I wanted to come to talk to you today about why we work, why the association and the cabinet work so well and smoothly together. And it's easy to say why we work, but I wanted to get into the nuts and bolts of how that happens. We've come a long way from the biblical times of PSEA when we took a scorched earth approach, not with me as president. When we go to conferences to talk to other associations, other associations are amazed at what we do and what is not done at most schools. It is called the PRC and SRC. The PRC or Perris Relationship Council is where the Association Executive Board and PUHSD cabinet meet once a month to talk about anything that currently needs to be talked about. The SRC or Site Relationship Council is where site administration meets with PSEA site representatives to talk about local issues. The SRC/PRC process was started in biblical times for PSEA when a very different PSEA, and a very different cabinet, were having a lot of conflicts. Besides just the

whole meeting part, there is a well-defined structure for the PRC/SRC and a few major concepts that I would like to highlight for you tonight that could be used for any group setting. Indeed, it could even be used for individual relationships. One of the biggest tenets of the PRC/SRC process is that we attack the problem, not the person. This ensures that we take many emotions and personal assumptions out of the equation. Speaking of assumptions, we try to check our assumptions in this day and age. Many assumptions are made about many things, and many people watch the news. These assumptions are often inaccurate, and, sadly, so many people drive their philosophies, sometimes their whole lives, on false assumptions. So it's really important that when we talk with the cabinet, we're checking our assumptions. We either ask, or we research those assumptions."

• "Another important thing is that we try to come up with concrete solutions instead of just having a complaint session. Here's the problem, here's a solution, and that's what drives a lot of PRC/SRC and our process. Also, when we were meeting, we dealt with relationship issues over substance. If we're talking about an item and the discussion gets personal, which it often does not, the discussion is postponed on the item to deal with the personal issue. Generally, this PRC/SRC process has successfully avoided grievances and different complaints that associations traditionally use to solve problems. In my opinion, the PRC/SRC process is a more sophisticated tool that is more fruitful than just fighting. It addresses the issues so we are not fighting just for the sake of fighting, which can happen with some association representative types and virtually every association. We strive to replace that fighting with solving, improving, and moving forward. Thank you for the time to speak."

## 9.6 Comments by the Board of Trustees

Trustee Vallejo stated she was glad to watch the videos of all the student reps, and it's great to see how much they have accomplished. She asked that everyone follow the COVID protocols to avoid a shutdown. She also stated she loves that many students are still attending school and learning and thinks that students learn best when doing in-person instruction. Finally, Trustee Vallejo noted that the Board is here for students and staff.

Trustee Freeman shared that he's been on the Board for three years, and it has been an experience. There have been many issues that the District had to face that he couldn't have imagined when he ran for the Board. He was pleased with Mr. Miller's statements. He feels that there is a very positive relationship between the District and the group representatives. He shared his experience on the Menifee board, which wasn't always this peaceful. Finally, Trustee Freeman feels the District will get through this and believes everyone will be much stronger for it.

Trustee Stafford thanked staff and students for being patient and following the standard operating procedures; this has been difficult for everyone. He shared that he enjoys working with the Board, Superintendent Bennett, and the Cabinet. He feels that they've gotten the District through some really tough times and feels everyone is prepared for anything.

# 10.1 INVITATION TO ADDRESS THE BOARD OF TRUSTEES: Non-Agendized Items

## Jade Lyon, Paloma Valley High School student, made the following statement:

"Good evening, board, and happy New Year. I know that you probably think I sound like a broken record, which is fine because I know that I'm advocating for myself and others. I've been trying to research masking effects, which is incredibly difficult. Still, I did manage to find an article published by USC, and the article states to discontinue mask wearing for all students, vaccinated or not. The benefits of masking and preventing serious illness or death from COVID-19 among children are infinitely small. At the same time, they are disruptive to learning and communicating in the classrooms. They may be partially, in fact, effective in shielding adults from COVID, but since when is it ethical to burden children for the benefit of adults? COVID-19 is less of a threat to children than accidents or the common flu. The survival rate among American children with confirmed cases is approximately ninety-nine percent. I hope you know that my mom and I and everyone else who has spoken at the board meetings are not coming up with made-up theories because this article is professional people doing research and saying that masking for students is not good. Like this article says, why are you forcing students to wear masks that affect their learning ability to protect adults? I'm tired of putting my mask on, not to protect myself, but to protect the adults around me when adults are the adults in the situation. This is the logic also being applied to the vaccine. People are expecting children to get a medical experiment to protect adults. I've always been told that adults are grown-ups and the people in charge of the situation. But now, it seems like I'm being expected to be the adult in the situation; that's reversing everything I've been taught. I'm asking you to please give people their own choice to wear a mask. Let people that want to wear the mask wear it, and people that are making their own choice in the free country of America make their own choice. And also, Dr. Freeman, you said that you're okay to disagree, correct? So all I'm asking is I hope that you truly meant that and that it's not falling on deaf ears. I'm in the classroom, I'm learning, and I cannot focus and think, and I can't focus on my work and don't want to do it because I have something that's scratching itchy on my face, and I can't breathe. And for me, that's hard, especially for my mask when I'm deaf in my ear, and you can clearly see that my ear is deformed, and I have to try to work around that to get the schooling that I need. Thank you."

## Emily Lyon, Paloma Valley High School parent, made the following statement:

"Good evening and happy New Year. It's been a little bit of time; we couldn't make the December meeting because my daughter was kicking butt in a volleyball game, so we weren't here. But I'm sure you didn't miss us too much. Anyway, I'm here tonight. I wrote several things down. I don't even know that I'm going to read from what I wrote, just because I need you to hear me from the heart as a mother. Obviously, the last year and a half have been difficult for everybody. It hasn't been easy on any one of us, and I don't think that it's been easy on you. I know you guys have faced many challenges, and there have been many difficult decisions. Piggybacking on Dr. Freeman's comment about it being okay to disagree. It hasn't been okay to disagree since the pandemic started. We have come here. We have been made to feel bad about our stance on things. There have been comments that have been made. There are reports that are given to make it sound as though people like myself and my daughter don't care about other people, and that's the furthest thing from the truth.

If you knew me, if you knew my heart, you would know my heart is for people; it's for you guys as well. I keep you guys in my prayers regularly, praying that first and foremost, you know, Jesus, and that beyond that, you are really in the position you're in. Seek counsel and guidance because there is a lot of information continually being censored right now. There is information, you guys. If you look at the various data, we should not be vaccinating children. Many experts, health experts, doctors, immunologists, and people are speaking out, saying we shouldn't be doing this to children. Yet they're being censored; they're being silenced, labeled as somehow inferior to other experts. And that's not how science works. Science is supposed to be experts from all different areas coming together, expressing things they've observed, things that they have found in their research, and that's not happening in any of this, and that should be startling to every one of us. If you want to know what's going on, you have to break away from listening to mainstream media reading just certain reports because it's not painting the whole picture. Even if you dig enough on the CDC website, you'll see there are discrepancies, and there are concerns, the very system. No, it's not proven that's what caused the issues, but that system was set up to be an early warning sign if there was something going on. And yet, we're ignoring those early warning signs, especially for children, and it's not okay. And I just am here tonight to beg and plead with you to please, please go beyond what's been given to you and do your own research. It's hard to find. You do have to dig, but it is out there. I'm tired of seeing names that make people like myself look like I'm somehow unintelligent and that I somehow am just following a meme on Facebook or doing this or doing that. How is my research any less valid than someone else's research? Because mine says something different. That's not how research works. Okay, so I just beg of you as a mom, as a concerned parent, that you please branch out and start looking for things if you genuinely care about the health and safety of students. Thank you."
