The following written public comment was received and read by Joseph Williams, Executive Director of Technology:

# Matthew Davis, Teacher at Paloma Valley High School:

Dear Members of the Board:

Please return our students with moderate/severe disabilities to in-person interaction and instruction.

The Governor, in late August, recognizing that students with disabilities were being harmed by not having in-person instruction and support, made in-person instruction and support possible through the Cohort model. The CDPH issued guidance in early September, for schools to provide targeted, specialized support and services at school.

According to a CDPH FAQ page "Which students can be served in cohorts during school closures? Students with disabilities should be prioritized by the LEA and school for receiving targeted support and services."

School athletic teams were also given the green light under CDPH guidance. The board members in October voted to return student-athletes to in-person on-campus interaction with peers and instruction from staff.

Please vote in favor or returning our students with moderate/severe disabilities to similar on-campus, in-face interaction and instruction via the cohort model. Thank you for your time.
