

**PERRIS UNION HIGH SCHOOL DISTRICT
RESOLUTION NO. 24:24-25**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR RETAIL AND
WHOLESALE MERCHANDISE SOLUTIONS AND SERVICES**

WHEREAS, the District wishes to utilize the Master Intergovernmental Cooperative Purchasing Agreement for retail and wholesale merchandise solutions and services districtwide; and

WHEREAS, the Region 14 Education Service Center ("Region 14 ESC"), lead agency for OMNIA Partners Cooperative Purchasing Program, ("OMNIA") conducted a competitive solicitation process for retail and wholesale merchandise solutions and services in accordance with Education code section 38110. Region 14 ESC awarded the contract ("OMNIA Contract") to Walmart Inc. ("Vendor"), and authorized other public agencies, including the District, to participate in the OMNIA Contract; and

WHEREAS, on September 5, 2023, the Region 14 ESC Board of Trustees awarded the OMNIA Master Contract to Walmart Inc. in accordance with all terms and conditions listed in the request for proposals and will expire August 31, 2026; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase retail and wholesale merchandise solutions and services from Vendor under existing contracts, such as the OMNIA Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases retail and wholesale merchandise solutions and services on the same terms and conditions as set forth in the underlying bid.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the retail and wholesale merchandise solutions and services from the Vendor under the same terms and conditions as the OMNIA Contract.
3. The Board has determined that piggybacking on the OMNIA Contract is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the OMNIA Contract between OMNIA and Walmart and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
