Basic Service Agreement

Handicap or Wheelchair Lift

Perris Union High School District

1. We will maintain the elevators, at the described job site, as follows. Using skilled service personnel, under our supervision, we will use all reasonable care to make sure the equipment is maintained in a good operating condition.
2. We will systematically, and regularly examine 2 times per year.
3. NOTE: Stadium Lifts are special operation and parts and some services are restricted to "Authorized Distributors" by manufacturer. Some repairs or services may need to be done by installing company.
4. Notify the Owner/Customer of recommended repairs and/or parts or materials needed plus labor.
5. Periodically examine the safety devices, door, door locks, gate switch.
6. Provide proper lubrication for the entire elevator system.
7. Examine electrical components, control, relays, buttons.
8. The customer agrees to pay for all parts and labor for repairs, billable at the current labor rate.
9. Calls For Service. Customer agrees to pay for all Calls for Service, time and materials. All charges to be made at our normal billing rate, in effect at the time of call or requested response time / date.
10. All maintenance work to be accomplished during normal working hours, and working days, as recognized by the elevator trade.
11. The Customer agrees to notify the company of any accident within 24 hours, and to immediately remove the power of any elevator that operates in an unsafe condition or conditions exist that could cause further damage to the equipment.
12. It is agreed that Integrity Elevator does not assume possession of, or control of, any part of the equipment, but such remains the owners exclusively. The Company shall not be held liable for any loss, damage or delay due to any cause beyond our reasonable control including, but not limited to: acts of government, strikes, lockouts, fire, explosion, theft, flood, riots, civil commotion, war, malicious mischief, or acts of God. Under no circumstances shall Integrity elevator be liable for consequential damages.

1. We will maintain the elevators, at the described job site, as follows. Using skilled service personnel, under our supervision, we will use all reasonable care to make sure the equipment is maintained in a good operating condition.
 2. We will systematically, and regularly examine, adjust, and lubricate as needed.
 3. Notify the Owner/Customer of recommended repairs and/or parts or materials needed plus labor.
 4. We agree to provide the following services:(Items #5 - 9)
 5. Periodically examine the safety devices.
 6. Provide proper lubrication for the entire elevator system.
 7. Examine electrical components.
 8. Perform a keyed test of the fire recall system and keep a record on site - as required by state code.
 9. **Annual Hydraulic testing NOT requiring test weights & Fire Service Operation tests requiring smoke or heat sensor activation as required by state code.** *Tests are required annually only on elevators installed after October 25, 1998. Repairs required by test failure are not included.*
*The cost of the alarm company is **not** covered and is the elevator owners responsibility.*

10. The following will be excluded in this agreement:(Items 11 -20)
11. Any underground cylinders, feed lines, or piping.
12. Hydraulic repairs, seals, valves, motors.
13. Hall doors, jambs, sills, car doors, car sills, cabs, cab lighting.
14. Emergency power, or phones.
15. Guide rails, or their alignment.
16. Any power feeders, main line fuses, or communication feeders.

17. Any damage, or problems due to water, blowing sand, or seismic activity.
18. Any repairs, parts, or labor required as the result of misuse, vandalism or tests of system, with or without load.
19. Any and all state mandated safety or load tests requiring **Test Weights**, or system upgrades required by new, or changing codes.
20. Any part, or component, that is obsolete, and is not available through normal vendors.
21. Call For Service. Customer agrees to pay for all Call For Service time and materials. All charges to be made at our normal billing rate, in effect at the time.
22. All work to be accomplished during normal working hours, and working days, as recognized by the elevator trade.
23. It is agreed that Integrity Elevator, Inc. (I.E) does not assume possession of, or control of, any part of the equipment, but such remains the owners exclusively.
