### CMITA President Angel Love-Behrens shared the following statement:

As everyone in this room can contest, teaching is hard. Every aspect of the education field is suffering from attack. Board members, superintendents, cabinet members, administrators, counselors, and teachers. We have spent more time in the last year talking about how to make the issues easier, addressing them to mend the psyche of all. I stand here to tell you NO progress has been made.

No matter the intentions, conversions, ideas, or suggestions, there has been no fix. Where I stand, it is darker than it was one year ago. Rifts between members are being made wider and deeper because of "miscommunication". If a teacher cannot take an emergency bathroom break with an AP covering their class for nine minutes without returning to a negative evaluation of the lesson the student is working on, what hope does that teacher have in a reduction of stress?

If a teacher happens to pick up their phone on the first ring to only be questioned on how they were able to get to the phone so quickly if they were actually teaching and monitoring their class, what hope does that teacher have of a reduction of stress?

If a discussion over a new department chair cannot happen without the admin molding it into a union conflict, what hope does the union president have in maintaining a civil environment amongst their members?

When the admin is responding to teachers about prep period usage for voluntary collaboration by a group of teachers by saying, "Your union says you can't. Your union president will be upset and say 'I can't allow you to". How does that union president fairly and equitably represent their members? Fight for their rights and better working conditions when all they hear from admin is I am the reason they can't do it.

I don't know how to mend the rifts between my unit with my members when there are so many things working against me. But that has never stopped me before. This year is coming to an end and a new year is just in front of us. My fight for my members will continue whether they know the ins and outs of what I do for them, and the admin will not block my attempts to continue to create a unit and contract that will help the teachers, counselors, clerks, admin, cabinet, and Board of Trustees. Thank you.

### 7.5 Principal's Update

Dr. I. Nicholas Milosavljevic, Principal, presented the following to the Board and Cabinet:

Dr. Milosavljevic provided the Board and Cabinet with an attendance update and thanked his CMI team
for all the work they have done to help improve attendance.

- Almost 300 new applications have been received for the next school year, and a waiting list has been created, which is very positive for CMI and the District.
- Once again, CMI will have a 100 percent graduation rate, which has been running steady for the last five years.
- The FAFSA completion rate is currently at 95 percent. CMI has had a few roadblocks this year, but it plans to continue supporting students in completing their packets.
- A-G completion rate continues to stay high at approximately 65 percent. An ESports program will be added next year, which will help with the completion rate.
- The suspension rate is currently at 1.27 percent. In comparison, the state average is approximately 3.4 percent. CMI is well below the state average. Dr. Milosavljevic credits his CMI team with utilizing other means of correction, working on relationships, and using support systems to help students.
- The state testing target is currently at 95 percent, and CMI is holding at 98 percent.
- CMI participates in a book club with parents. This is a weekly event, and it's incredible to work with them. The current book being reviewed is Five Love Languages.
- Lastly, Teacher Appreciation Week for CMI is going strong. There have been daily activities and gifts of appreciation given to the teachers. A video was shared by CMI teachers.

# 8.1 INVITATION TO ADDRESS THE BOARD OF TRUSTEES: Non-Agendized Items

### Kimberly Nelson shared the following statement.

"Good evening, Trustees, Superintendent, Cabinet. Today, I stand here before you to address an unexpected challenge. One that not only jeopardizes the operation of student organizations but also undermines the very principle of fairness and equality upon which our school community at CMI is founded. I envisioned a space for students, regardless of gender, could come together with passion and dedication to explore computer technology. A vision embodied in the afterschool program known as Girls Who Code. This is a worldwide program with partners from school districts, County Offices of Education, such as RCOE, library networks, colleges, and afterschool programs to help close the gender gap in the text industry in the K-12 classrooms. Despite its name, this club is open to all students who share an interest in learning valuable 21st-century skills for the future. Yet, despite the potential contribution these students can make to our school, Girls Who Code finds itself burdened with a requirement no other club on our campus has been asked to bear unless venturing into the community and embarking on field trips. I speak, of course, about the imposition of parental permission slips signed upon this proposed club, a mandate that reeks of inconsistency and discrimination. While I understand the importance of parental involvement and oversight, I cannot ignore the glaring disparity and treatment faced by Girls Who Code and myself as the club advisor. Let me be clear: I do oppose measures ensuring the safety and well-being of our students by no means. However, singling out this club or any one club for such a requirement is unjust and baseless. I simply seek to facilitate after-school meetings in a classroom, like many other clubs, responsibly and effectively without unnecessary constraints. Moreover, this decision sets a dangerous precedence, undermining the autonomy of student-led organizations. By arbitrarily imposing requirements we erode student's rights to assemble and express themselves freely. I must ask 'Why us? "Why this club and not others?" Is it due to the nature of our activities or simply an attempt

to hinder the establishment of this club with me as an advisor. Whatever the reason is, it is imperative to resist such injustice and demand equal treatment. I call upon all members of our school community to unite against this injustice of requiring parental permission slips at the ready in a file for no apparent reason and advocate for fairness and equality for all students and clubs. In the face of adversity, we must stand resolute, undeterred by obstacles, and our voices must be heard. And together, we can ensure that no student or organization faces such unequal treatment and guidelines again. Thank you."

### Gail Collins shared the following statement.

"Good afternoon. I'm one of the counselors at CMI and just wanted to take an opportunity tonight in front of our Board members and our Cabinet to share good news from CMI. This year has been a wonderful example of collaboration among staff as we work together to build a positive school culture. Our momentum continues with a focus on the future as we expand our leadership team for next year to create improved communication systems, always with a focus on the right work to improve student learning. A lot of this progress could not have happened without our leadership team and the support of our administrators. We thank you for your support as we continue our collective efforts. Have a good evening."
