This Tentative Agreement is made and entered into this 1st day of May 2020, by and between the PERRIS UNION HIGH SCHOOL DISTRICT, hereinafter referred to as the "District", and CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION, AND ITS CHAPTER, PERRIS VALLEY CHAPTER #469, hereinafter referred to as "CSEA" or "Association", hereafter collectively referred to as "the Parties".

Recitals:

1. The District has an immediate need to move furniture from the Administration Building at Perris High School to prepare for a major renovation.
2. Due to the coronavirus pandemic all schools in the district are closed.
3. Only essential classified employees performing essential services are reporting to sites.
4. The District is providing personal protection equipment and health and safety measures (hand sanitizing, face coverings, social distancing) for all essential classified employees.
5. The parties recognize that moving of furniture at Perris High is not an essential service and not all safety measures may be followed.

The parties agree as follows:

1. No earlier than May 11, 2020, the district will utilize an outside contractor to move the furniture and equipment from the administration building at Perris High School in preparation for the renovation of the building.
2. The parties agree that due to COVID-19 this work cannot be performed safely by bargaining unit members.
3. This agreement sunsets on June 30, 2020.
4. This is non-precedent setting.
5. This agreement is subject to CSEA Policy 610 review as well as PUHSD Governing Board approval.






