Principal, Dr. I. Nicholas Milosavljevic, provided the Board with the following update:

- CMI Attendance is at 98.34 percent and enrollment remains steady at 1,046
- CMI custodial staff received a grade of A+ from the County Health Inspection team. They are doing good work on the campus.
- Staff will receive training through a program that is designed to reward students, 5Star Student Engagement. Staff will also obtain training from the Paper.Co Tutoring to help students find assistance on schoolwork that they struggle with.
- Over 400 cadets were able to "rank up" during cadet promotions. This shows testament to the students as they continue to stay engaged while virtual learning.
- CMI athletes were able to begin conditioning on campus and were very happy to be back on the field.
