ERWC i3 Validation Study
Amendment 01 Scope of Work: Additional Randomized Controlled Trial in 11th Grade
Requirements for the 2020/2021 School Year

District Responsibilities

1. Provide WestEd with student-level data up to three times throughout the 2020/2021 school year, including demographic data, Interim Assessment Block (IAB) data, and Smarter Balanced English Language Arts (ELA)/Literacy Summative Assessment data (or data from an alternative assessment if that assessment is cancelled).
2. Distribute school stipends received from WestEd to schools.
3. Process amended subcontract.

School Responsibilities

1. Provide a list of the student identification numbers of students entering 11th grade in the 2020/2021 school year to WestEd. WestEd will then randomize these students to either the ERWC or the traditional English curriculum (students taking Advanced Placement English, International Baccalaureate English, Honors English, and English Language Development courses will not be randomized). The school will place students into the English 3/11 curriculum based on the random assignment designated by WestEd.
2. Ensure that at least 90% of the students are enrolled in the 11th grade English curriculum that they were assigned to based on the above described randomization process in the 2020/2021 school year.
3. Ensure students remain in their assigned courses.
4. Provide rosters throughout the year showing that students were properly placed.
5. Make sure that all teachers (11th grade ERWC and 11th grade non-ERWC teachers) agree to participate next year.
6. Oversee the administration of an IAB at the beginning of the school year.
7. Oversee the administration of the Smarter Balanced ELA/Literacy Summative Assessment (or alternative assessment if that assessment is cancelled) at the end of the school year.
8. Ensure high rates of student participation in the two above-mentioned assessments.
