

**PERRIS UNION HIGH SCHOOL
DISTRICT RESOLUTION NO. 18:22-23**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR PURCHASE OF
COMMERCIAL KITCHEN EQUIPMENT WITH RELATED SUPPLIES
AND SERVICES**

WHEREAS, the District wishes to utilize the Cooperative Purchasing Contract to purchase various Commercial Kitchen Equipment with Related Supplies and Services for use at District sites; and

WHEREAS, Sourcewell, a State of Minnesota local government unit and service cooperative, ("Sourcewell") conducted a competitive solicitation process for the purchase of commercial kitchen equipment with related supplies and services in accordance with Education code section 38110. Sourcewell awarded the contract ("Sourcewell Contract") to responsive suppliers, and authorized other public agencies, including the District, to participate in the Sourcewell Contract; and

WHEREAS, on August 2, 2022, Sourcewell awarded the Sourcewell Cooperative Purchasing Contract to Cook's Direct, Inc., Stafford Smith, Inc., and Strategic Equipment ("Suppliers") in accordance with all terms and conditions listed in the request for proposals; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase various commercial kitchen equipment with related supplies and services from Suppliers under existing contracts, such as the Sourcewell Contract, without advertising for bids, if the Board determines it is in the best interests of the District, and the District purchases commercial kitchen equipment with related supplies and services on the same terms and conditions as set forth in the underlying bid.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of commercial kitchen equipment with related supplies and services from the Suppliers under the same terms and conditions as the Sourcewell Contracts.
3. The Board has determined that piggybacking on the Sourcewell Contracts is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the Sourcewell Contracts between Sourcewell and Cook's Direct, Inc., Stafford Smith, Inc., and Strategic Equipment pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
