

**PERRIS UNION HIGH SCHOOL  
DISTRICT RESOLUTION NO. 04:22-23**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR PURCHASE OF  
MAINTENANCE AND INDUSTRIAL SUPPLIES**

**WHEREAS**, the District wishes to utilize the Master Intergovernmental Cooperative Purchasing Agreement to purchase various Maintenance and Industrial Supplies for use at the District school sites; and

**WHEREAS**, the Maricopa County, lead agency for U.S. Communities Government Purchasing Alliance, ("UCGPA") conducted a competitive solicitation process for the purchase of various Maintenance and Industrial Supplies in accordance with Education code section 38110. Maricopa County awarded the contract ("UCGPA Contract") to the responsive supplier, and authorized other California School districts, including the District, to participate in the UCGPA Contract; and

**WHEREAS**, on January 11, 2017, the Maricopa County Board of Trustees awarded the UCGPA Master Contract to Home Depot ("Supplier") in accordance with all terms and conditions listed in the request for proposals, and said award has been extended through December 31, 2026; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase various Maintenance and Industrial Supplies from Supplier under existing contracts, such as the UCGPA Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases Maintenance and Industrial Supplies on the same terms and conditions as set forth in the underlying bid;

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of Maintenance and Industrial Supplies from the Supplier under the same terms and conditions as the UCGPA Contract.
3. The Board has determined that piggybacking on the UCGPA Contract is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the UCGPA Contract between UCGPA and Home Depot and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
