## RESOLUTION AUTHORIZING THE PIGGYBACKING OF BID AWARD #21/22-001 JUST N TIME CLASSROOM AND OFFICE SUPPLIES DISTRICT WIDE FOR THE PURCHASE OF CLASSROOM AND OFFICE SUPPLIES

**WHEREAS**, on May 25, 2021, the Val Verde Unified School District (VVUSD) requested sealed bids, under Request for Bids # 21/22-001, Just-N-Time Classroom and Office Supplies; and

WHEREAS, bids were received by VVUSD and evaluated; the bids were requested, advertised, accepted, and evaluated in accordance with the provisions of the California Public Contract Code and the Education Code. VVUSD awarded the contract ("VVUSD contract") to the responsive and responsible vendor, and authorized other public agencies, including the District, to participate in the VVUSD contract;

WHEREAS, on June 15, 2021, the Governing Board of the Val Verde Unified School District awarded the Contract to Southwest School and Office Supplies ("Vendor") in accordance with all terms and conditions listed in the bid documents. On May 27, 2022 the VVUSD Governing Board approved to extend the contract with Hollandia Dairy for a one (1) year term that will be valid from June 15, 2022 through June 14, 2023; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase various Classroom and Office Supplies from Vendor under existing contracts, such as the VVUSD Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases Classroom and Office Supplies on the same terms and conditions as set forth in the underlying bid;

## NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

- 1. The foregoing recitals are true and correct.
- 2. The Board hereby approves the purchase of Classroom and Office Supplies from the Supplier under the same terms and conditions as the VVUSD Contract.
- 3. The Board has determined that piggybacking on the VVUSD Contract is in the best interest of the District.
- 4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the VVUSD Contract between VVUSD and Southwest School & Office Supplies and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
