

**PERRIS UNION HIGH SCHOOL
DISTRICT RESOLUTION NO. 02:23-24**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR PURCHASE OF
ATHLETIC AND PHYSICAL EDUCATION SUPPLIES**

WHEREAS, the District wishes to utilize the Master Intergovernmental Cooperative Purchasing Agreement to purchase various Athletic and Physical Education Supplies for use at the District school sites; and

WHEREAS, the Region 4 Education Service Center ("Region 4 ESC"), lead agency for OMNIA Partners Cooperative Purchasing Program, ("OMNIA") conducted a competitive solicitation process for the purchase of Athletic and Physical Education Supplies in accordance with Education code section 38110. Region 4 ESC awarded the contract ("OMNIA Contract") to the responsive supplier, and authorized other public agencies, including the District, to participate in the OMNIA Contract; and

WHEREAS, on August 25, 2020, the Region 4 ESC Board of Trustees awarded the OMNIA Master Contract to BSN Sports, LLC ("Supplier") in accordance with all terms and conditions listed in the request for proposals; and

WHEREAS, on April 25, 2023 the Board of Directors of Region 4 Education Service Center announced that the Supplier had been awarded an annual contract renewal that will expire September 30, 2024, completing the fourth year of a five-year term contract; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase various Athletic and Physical Education Supplies from Supplier under existing contracts, such as the OMNIA Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases Athletic and Physical Education Supplies on the same terms and conditions as set forth in the underlying bid.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of Athletic and Physical Education Supplies from the Supplier under the same terms and conditions as the OMNIA Contract.
3. The Board has determined that piggybacking on the OMNIA Contract is in the best interest of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the OMNIA Contract between OMNIA and BSN Sports, LLC and, pursuant to the "piggybacking"

procedures of Public Contract Code section 20118, and to execute any documents and take all necessary actions to effect the intent of this Resolution.
