## PERRIS UNION HIGH SCHOOL DISTRICT

### **AGREEMENT FOR PROFESSIONAL SERVICES - AMENDMENT NO. 5**

This Amendment to the Agreement for Professional Services, made and entered into this 13th day of February, 2020, by and between the Perris Union High School District of Riverside County, California, hereinafter referred to as "DISTRICT" and Clover Enterprises, hereinafter referred to as "CONTRACTOR".

WHEREAS the DISTRICT and CONTRACTOR entered into an Agreement for Professional Services (Athletic Training/1st Responder Services at Perris High School, Paloma Valley High School, Heritage High School, and Pinacate Middle School) on July 1, 2015.

NOW, THEREFORE, the parties agree as follows:

- 1. Modify Section 5: FEES of the Agreement as follows:
  - 1.1. Perris High School:

August 1, 2019 through January 31, 2020 (30 Hours Per Week) The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$34.00 per hour with a total fee not to exceed \$26,928. Time will be tracked on a District timesheet. The District will pay said total fee in six (6) equal installments of \$4,488 on the first (1st) day of each month for the prior month's services. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

February 1, 2020 through May 29, 2020 (30 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$40.29 per hour with a total fee not to exceed \$21,273.12. Time will be tracked on a District timesheet. The District will pay said total fee in four (4) equal installments of \$5,318.28 on the first (1st) day of each month for the prior month's services. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

June 1, 2020 through July 31, 2020 (15 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$40.29 per hour with a total fee not to exceed \$4,834.80. Time will be tracked on a District timesheet. This will be based on the hours submitted at the end of each month. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

1.2. Paloma Valley High School:

August 1, 2019 through January 31, 2020 (30 Hours Per Week) The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$34.00 per hour with a total fee not to exceed \$26,928. Time will be tracked on a District timesheet. The District will pay said total fee in six (6) equal installments of \$4,488 on the first (1st) day of each month for the prior month's services. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties. February 1, 2020 through May 29, 2020 (30 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$40.29 per hour with a total fee not to exceed \$21,273.12. Time will be tracked on a District timesheet. The District will pay said total fee in four (4) equal installments of \$5,318.28 on the first (1st) day of each month for the prior month's services. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

### June 1, 2020 through July 31, 2020 (15 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$40.29 per hour with a total fee not to exceed \$4,834.80. Time will be tracked on a District timesheet. This will be based on the hours submitted at the end of each month. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

1.3. Heritage High School:

August 1, 2019 through January 31, 2020 (30 Hours Per Week) The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$34.00 per hour with a total fee not to exceed \$26,928. Time will be tracked on a District timesheet. The District will pay said total fee in six (6) equal installments of \$4,488 on the first (1st) day of each month for the prior month's services. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

# February 1, 2020 through May 29, 2020 (30 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$40.29 per hour with a total fee not to exceed \$21,273.12. Time will be tracked on a District timesheet. The District will pay said total fee in four (4) equal installments of \$5,318.28 on the first (1st) day of each month for the prior month's services. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

### June 1, 2020 through July 31, 2020 (15 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Perris High School at a rate of \$40.29 per hour with a total fee not to exceed \$4,834.80. Time will be tracked on a District timesheet. This will be based on the hours submitted at the end of each month. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

1.4. Pinacate Middle School:

August 12, 2019-October 25, 2019 and January 13, 2020-January 31, 2020 (15 Hours Per Week)

The District agrees to pay Contractor for Services satisfactorily rendered at Pinacate Middle School at a rate of \$34.00 per hour with a total fee not to exceed \$6,630. This will be based on the hours submitted at the end of each month. In the event of a change to the

length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

February 1, 2020 - May 15, 2020 (15 Hours Per Week) The District agrees to pay Contractor for Services satisfactorily rendered at Pinacate Middle School at a rate of \$40.29 per hour with a total fee not to exceed \$9,065.25. This will be based on the hours submitted at the end of each month. In the event of a change to the length of the Term, the compensation due Contractor under this Agreement shall be prorated based on the start and end date of the Services as agreed upon by the parties.

TOTAL INCREASE: This represents a total increase in the contract in the amount of \$13,643.01.

OBLIGATIONS UNDER THE AGREEMENT: The parties agree that all terms, conditions, and obligations of the agreement remain in effect throughout the Term except for those provisions of the agreement that are directly contradicted by this pricing change, in which event the terms of this extension shall control over the agreement.

SEVERABILITY: If any part or parts of this extension shall be held unenforceable for any reason, the remainder of the extension shall continue in full force and effect.
