4.1 Student Representative to the Board of Trustees

CMI student representative Cadet Captain Ariana Abrisz-Smith gave a video report to the Board of Trustees on the events and activities taking place at the school site.

4.2 CMITA President Angel Love-Behrens

CMITA President Angel Love-Behrens shared the following statement:

"Good evening President Garcia and Superintendent Bennett. January 19, 2001, was my first day as an employee of this district. In all the years I have been a part of this institution, the Board of Trustees, the Cabinet, and the Superintendents have worked hard at keeping cuts as far from the classroom as possible. I stand here hoping that mindset continues with this Board, this Cabinet as we stare down what looks to be another tough financial period for schools up and down the state of California. I've been assured, at least

temporarily for now by Mr. Skorpanich and my principal, that's not in discussion for CMI right now. I hope it stays that way, but I am a realist. I know a lot of that is out of our control, especially mine being at the site. It is somewhat in your control. But some of that control lies in Sacramento. There is one thing, one action, I can take that can hopefully help in some small way. I will be attending a lobbying session with CTA in Sacramento in June, where we are going to be addressing, specifically, assembly and district senate members from our district about the budget. And my plea to them will be to keep the cuts at the state level as far away from the classroom as we can. It is the only thing that I can do in the face of what we're looking at. So I hope my voice at that level is heard.

On a lighter note, I am pleased to inform you all that our negotiations are going well. We have a few articles that have been able to TA. Thanks to Kirk, Maribel, Candace, Mayra, and Dr. M. for working really well with us. Our main focus for the renewal of our CBA this year is clarifying language. We have all the hard parts of our contract, so that misinterpretation is decreased and understanding is increased on it. That's what we're seeking this year. One major discovery that has been made is that we need a handbook. We don't have a teacher handbook for our site. PSEA is great, but like everything else, we're kind of the oddball out, and not all of it applies to us. So we look forward to hopefully meeting with the new people in Student Services and hopefully make that happen sooner than later. I don't want to wait another 10-12 years for a handbook.

As my unit members head into the back half of the semester, with finals, graduation, and the end of the 23-24 school year coming at us at warp speed, we are busier than ever with interventions, ELPAC testing, preparation for SBAC, finals, grades, parent and teacher conferences, meetings, and phone calls, as well as looking at the 2024-2025 school year. Thank you for your time."

4.3 CSEA President Rosa Galvan

CSEA President Rosa Galvan shared the following statement:

"Good evening Board of Education, Superintendent, Mr. Bennett, and others here today. My name is Rosa Galvan, the Chapter President of the California Military Institute Chapter 778 of the California School Employees Association for the second year. I am here to formally introduce our new Executive Board officers for the 2024 term. Our new secretary, Christina Sanchez, and new Treasurer, Tracy Assimakopoulos. We are very excited to continue working with the charter this year. Our chapter is moving forward, and soon we'll have two more positions on the board. We are very proud of our memberships for making this happen. I have also applied for delegate assistance to represent our chapter at the CSEA annual conference on July 28-Aug. 1, 2024, in San Jose. I am hoping to hear from them soon. Also, our negotiations team, along with me and our CSEA laborer relationships representative, Myisha Kennedy, have been very dedicated and working persistently with CMI administration and the District to wrap up negotiations for our first contract ever. I have to say that we are addressing any items as they arise in a very reasonable, elective and timely manner. I have experienced and learned so much about our powerful union and the work CSEA does to improve the lives of our members, students, and our community. We look forward to working with CMI administration, the District, and this Board of Education as we continue moving forward in our journey as a California Schools Employees Association and its CMI Chapter 778. 4.4 Principal's Update

Dr. I. Nicholas Milosavljevic, Principal, provided the Board and Cabinet with a slide presentation on the following:

- Enrollment Update—CMI has received over 250 new applications for the next school year. This shows that the community trusts the work of the teachers and classified staff and is a testament to the quality of the school.
- Attendance for March is at 95 percent.
- CMI has received a "Superior" rating during its annual General Inspection three years in a row. Over 1,000 cadets stand at attention while representatives from the various branches inspect them. Dr. Milosavljevic thanked parents and staff for making this a wonderful event.
- CMI was invited to apply for a PBIS Silver status school, and the pre-evaluation visit is on Friday, March 22nd.
- CMI was also invited to apply for the PLC Promising Practices site through Solution Tree. Promising Practices is a solid initial step to becoming a Model PLC at Work school. Promising Practices schools have strong evidence of the solid foundation required to become a Model PLC at Work and share at least one year of data that shows student achievement growth. This is a difficult process and Dr. Milosavljevic will keep the Board updated on future statuses.
- Lastly, ELPAC testing is 98 percent complete. Dr. Peterson, the EL coach, is leading the work alongside the testing coordinator, Ms. Harpley, and her staff. Dr. Milosavljevic shared that he was very proud of the team and the work they have done.
