

**PERRIS UNION HIGH SCHOOL DISTRICT  
RESOLUTION NO. 18:23-24**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR THE PURCHASE OF  
ARTIFICIAL TURF AND TRACKS WITH INSTALLATION, RELATED  
EQUIPMENT, MATERIALS, AND SUPPLIES**

**WHEREAS**, the District wishes to purchase various Artificial Turf and Tracks with Installation, Related Equipment, Materials, and Supplies for use at District school sites in an estimated amount of \$890,120 (“Contract Price”); and

**WHEREAS**, the Sourcewell Cooperative (“Sourcewell”), conducted a competitive solicitation process for the purchase of Artificial Turf and Tracks with Installation, Related Equipment, Materials, and Supplies in accordance with Public Contract Code section 20111. Sourcewell awarded the contract (“Sourcewell Contract”) to Hellas Construction, Inc., and authorized other California School districts, including the District, to participate in the Sourcewell Contract; and

**WHEREAS**, on May 23, 2022, the Sourcewell awarded the Contract to Hellas Construction, Inc. ("Supplier") in accordance with all terms and conditions listed in the request for proposals; and the contract is valid through May 26, 2026 and may be extended one additional year upon written agreement; and

**WHEREAS**, California Public Contract Code section 20118 authorizes the Board to purchase Artificial Turf and Tracks with Installation, Related Equipment, Materials, and Supplies from Supplier under existing contracts, such as the Sourcewell Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases Artificial Turf and Tracks with Installation, Related Equipment, Materials, and Supplies on the same terms and conditions as set forth in the underlying contract;

**NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:**

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of Artificial Turf and Tracks with Installation, Related Equipment, Materials, and Supplies from the Supplier under the same terms and conditions as the Sourcewell Contract.
3. The Board has determined that piggybacking on the Sourcewell Contract for the purchase of the needed Artificial Turf and Tracks with Installation, Related Equipment, Materials, and Supplies is in the best interests of the District.
4. The Board has determined that minor installation costs constituting only up to 20% of the Contract Price, to be provided by Supplier upon delivery, are incidental to the total

amount to be paid by the District under the Sourcewell Contract, which is intended predominately for District facilities.

- 5. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the Sourcewell Contract between Sourcewell and Hellas Construction, Inc. and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, to execute any documents and take all necessary actions to effect the intent of this Resolution.
