Memorandum of Understanding Between Perris Union High School District and Make-A-Wish Foundation of Orange County and the Inland Empire, Inc.

This Memorandum of Understanding ("MOU") is entered into on November 19, 2020 between Perris Union High School District ("District") and the Make-A-Wish Foundation of Orange County and the Inland Empire, Inc. ("Foundation").

WHEREAS, a District student has been granted a wish from the Foundation. The wish includes the following elements: a) repainting the Heritage High School weight room and painting the school mascot on the wall; b) a new white board; and c) new gym equipment. All improvement will not exceed \$7,200.00.

WHEREAS, the District is supportive of granting the student's generous wish and receiving the donation to benefit District students in accordance with the terms set forth herein.

THEREFORE, the parties agree as follows:

- 1. The Foundation will donate to the District up to the amount of \$7,200.00 towards the redecoration of the weight room. These funds will be used for the above mentioned items and will not exceed \$7,200.00.
- 2. The District will purchase the paint for the repainting of the weight room.
- 3. The District will request that its Maintenance and Operations staff paint the weight room when non-essential services are permitted to return to campus following the closure due to COVID-19 pandemic.
- 4. The District will purchase and install the whiteboard.
- 5. The District will retain Gorilla Team Artists, or another artist of its choosing, to paint the mural. The mural should be consistent with the current style of the school site mascot and be approved by District Administration.
- 6. The District has identified the equipment it currently has in the weight room and that is eligible for replacement in Exhibit A. The Foundation will notify the District which of this equipment it intends to replace. In the event there is a newer model of equipment available or desired, the Foundation and Athletic Director can modify the list of equipment to be donated.
- 7. The District will arrange for removal of old equipment and installation of new equipment.

- 8. The Foundation may terminate this MOU and the donation at any time prior to removal of the existing gym equipment.
- 9. The parties agree to hold each other harmless in the event there is a personal injury and/or any resulting damage incurred in conjunction with this donation.
- 10. This MOU constitutes a full and complete agreement between the parties.
