

**PERRIS UNION HIGH SCHOOL DISTRICT
RESOLUTION NO. 24:23-24**

**RESOLUTION AUTHORIZING PIGGYBACKING FOR PURCHASE OF THE
EDMENTUM SOFTWARE**

WHEREAS, the District wishes to purchase the Edmentum Software for use Districtwide in an estimated amount of \$449,290.60 (“Contract Price”); and

WHEREAS, The Interlocal Purchasing System (“TIPS”), conducted a competitive solicitation process for the purchase of Technology Solutions, Products, and Services in accordance with Public Contract Code section 20111. TIPS awarded the contract (“TIPS Contract”) to Edmentum, and authorized other California School districts, including the District, to participate in the TIPS Contract; and

WHEREAS, on May 5, 2023, TIPS awarded the Contract to Edmentum ("Supplier") in accordance with all terms and conditions listed in the request for proposals; and the contract is valid through May 31, 2028; and

WHEREAS, California Public Contract Code section 20118 authorizes the Board to purchase the Technology Solutions, Products, and Services from Supplier under existing contracts, such as the TIPS Contract, without advertising for bids, if the Board determines it is in the best interest of the District, and the District purchases the Technology Solutions, Products, and Services on the same terms and conditions as set forth in the underlying contract;

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE PERRIS UNION HIGH SCHOOL DISTRICT DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The Board hereby approves the purchase of the Edmentum Software from the Supplier under the same terms and conditions as the TIPS Contract.
3. The Board has determined that piggybacking on the TIPS Contract for the purchase of the Edmentum Software is in the best interests of the District.
4. The Deputy Superintendent of Business Services, Candace Reines, or Admin Designee, is authorized in the name of and on behalf of the District to utilize the TIPS Contract between TIPS and Edmentum and, pursuant to the "piggybacking" procedures of Public Contract Code section 20118, to execute any documents and take all necessary actions to effect the intent of this Resolution.
